
# **Commercial Fishing for European Sea Bass in 2024**



This information summarises national legislation applied to commercial bass fisheries within the district of the Cornwall Inshore Fisheries and Conservation Authority.

## **Bass fishing restrictions**

Commercial fishing for bass from the shore is prohibited throughout 2024.

Fishing for bass by UK fishing vessels is prohibited during February and March 2024.

#### Demersal trawls

For unavoidable by-catches of bass not exceeding 3.8 tonnes per year and 5% of the weight of the total catches of marine organisms on board caught by that vessel per fishing trip;

#### <u>Seines</u>

For unavoidable by-catches of bass not exceeding 3.8 tonnes per year and 5% of the weight of the total catches of marine organisms on board caught by that vessel per fishing trip;

## Hooks and lines

Only where the vessel has recorded catches of bass using hooks and lines over the period from 1 July 2015 to the end of September 2016, not exceeding 6.2 tonnes per vessel per year;

#### **Fixed gillnets**

Only where the vessel has recorded catches of bass using fixed gillnets over the period from 1 July 2015 to the end of September 2016, for by-catches not exceeding 1.6 tonnes per vessel per year.

For fishing vessels using more than one gear in a single calendar month, the lowest catch limit as set out above, shall apply.

It is prohibited for fishing vessels to catch and retain bass with any other gears, including nets that drift with the current or are capable of doing so.

Commercial fishing for bass from an unlicensed vessel without an engine is not prohibited at any time of year, except at certain times within a bass nursery area (See BNA information below).

#### Minimum size for bass

The minimum conservation reference size for European sea bass is 42cm. Any undersized bass must be immediately returned to the sea.

## Landing obligation

The landing obligation does not apply to bass. Therefore, where bass is caught using unauthorised fishing gear, or where it exceeds the prescribed catch limit using authorised gear, it must be discarded.

# **Bass Nursery Areas**

Six of the larger rivers and estuaries within the Cornwall IFCA district include areas where fishing for bass from a boat is prohibited, and also where fishing from a boat for any species of sea fish using sand eels as bait is prohibited, at certain times of the year:

<u>Plymouth Rivers</u> All tidal waters enclosed by a line drawn from the western end of Mountbatten Pier 268°T to the landing beacon at Wilderness Point in the River Tamar	All year
<u>River Fowey</u> All tidal waters enclosed by a line drawn 270° true from Penleath Point to the opposite shore	May to December (incl.)
<u>Fal Estuary</u> All tidal waters enclosed by a line drawn 045° true from Weir Point to Turnaware Point	May to December (incl.)
<u>Percuil River</u> All tidal waters enclosed by a line drawn 151° true from St Mawes Castle to Carricknath Point	May to December (incl.)
<u>Helford River</u> All tidal waters enclosed by a line drawn 199° true from Rosemullion Head to Dennis Head	May to December (incl.)
<u>River Camel</u> All tidal waters enclosed by a line drawn 020° True from Stepper Point to Pentire Point.	May to November (incl.)

Any bass caught when fishing from a boat in the specified areas at prohibited times of the year is to be immediately returned to the sea.
