Dear Parent/Carer,

We contacted you in the summer to inform you of the outcome of the review into parent carer participation in Haringey. The review recommended establishing a parent carer forum in Haringey and this is something that we would like to put in place.

The parent carer forum will consist of a group of parents and carers of children and young people with special educational needs and disabilities (SEND) who work with the council, education settings, health providers and other providers to make sure the services we plan and deliver meet the needs of children and young people with SEND and their families.

There are approximately two and a half thousand parents and carers in Haringey whose children have SEND and whose voices need to be heard. Our proposal is to ask an expert independent organisation to develop a model for the parent carer forum and to help support all parents and carers to become more involved. This will help us to make sure that the way we work to support children and young people with SEND and their families is better informed by the views of parents, children and young people going forward.

We will be holding virtual events via zoom or Microsoft Teams on **Monday 2 November and Thursday 5 November 2020** to discuss how we take this forward.
