## CHANGES TO THE THA ARTICLES

Tobermory Harbour Association proposes to change the company Articles of Association (our constitution). The membership was unduly complex and not totally open to all. These changes are to bring the THA in line with the latest thinking by the Scottish Government and by Funders on the Governance and conduct of Community Companies.

For your convenience, we have highlighted the areas that have been revised, as follows:

#### **DEDFINED TERMS:**

New terms to cover community definitions have been added (see 2.4, 2.5, 2.7, 2.11, 2.12, 2.15)

#### **OJECTS:**

The Community is now specified and includes all from the North of Mull. Specifically, postal code areas PA72, PA73, PA74, PA75 (see 4)

An additional sentence on sustainable development (see under 4.5)

Additional point on community bodies and reporting amendments to Scottish Ministers (see 7)

## **POWERS:** (now under section 8 instead of 7 as in previous versions)

Additional points to include community land and associated assets and the relevant acts. (see 8.2, 8.21, 8.22)

# RESTRICTIONS ON USE OF COMPANY'S ASSETS (now under 9 instead of 8)

Additional restriction placed on surplus funds/assets to be applied for the benefit of the community (see 9.1)

Removal of section 9.2 in previous versions, restricting the transfer or payment to a member for charitable purposes.

Categories of membership have been re-defined (see 13, 14)

Please read section **15-36** for new terms and conditions of membership.

Additional clause adding the website as a place where notices can be viewed. (see 46.3)

## PROCEEDINGS AT MEETING

## **CATEGORIES OF DIRECTORS**

All the complex categories of Directors from Stakeholder Groups to formally Constituted Groups has been stripped out. The term 'stakeholder director' will now cease to exist and the new term 'member director' will be used from now on (see 72 - 88 for the details on the composition of the board and the process for election). The number of directors (now referred to as 'member directors') have changed from 10 to 9, Executive Directors have increased from 2 to 3 (see 74).

## PROCEEDINGS OF DIRECTORS:

Additional points in this section have been added;

**119** - chairperson not entitled to vote if they are not an ordinary member.

121 & 123 - new quorum procedures.

133 - ensuring that directors cannot vote on matters relating to their own remuneration.

## **MINUTES:**

Additional section stipulating that minutes can be requested by anyone and must be provided within 28 days, providing it is a reasonable request. (see 157)

## WINDING UP:

Additional section referring to land reform acts, etc. (see 170)

# **REGISTER OF DIRECTORS INTERESTS:**

The secretary must now maintain a register of Directors Interests (see 104 and 99 - 106).
