2 1 st May 1972	Registration amendment: the parts of the land comprised in this register unit shown by violet hatching on the third edition of the Register Map ceased to be town or village green and are removed from the register with the consent in writing of the applicant whose name and address appear in entry number 1 above.
3 8 th May 1972 (See entry No. 4 below)	Modification of entry number 1 above: the three pieces of land as marked verged green inside and with a red interrupted line on their boundaries shown on the third edition of the Register Map and distinguished by the number of this register unit. The Register Map replaces the first and second editions of the Register Map (Registration Provisional)
4 18 th August 1972	The registration at entry No.3 above, being undisputed, became final on 1 st August 1972.
