Board meeting held on 7 May 2015

## KEY DECISIONS

- To agree a [business plan](#) for 2015-16 with a focus on the toxic trio (substance misuse, domestic abuse and mental health), neglect, early help, and child and adolescent mental health.
- To note the positive outcome from the recent multi-agency audit of MASH which showed a strong front-door into social care and consistent use of thresholds.
- To agree that the theme for the [Annual Conference](#) on 23 October 2015 should be the impact of the toxic trio on parenting capacity and keeping children safe.
- To approve the establishment of a Workforce Development Group for the Isle of Wight, to be chaired by Alison Smailes from the Youth Offending Service.
- To sign-off the IOWSCB [Rapid Response Procedure](#) for immediate implementation on the Isle of Wight.
- To approve the 2015-16 budget and partner contributions.
