



## Partnership Board meeting - Wednesday 24th January 2024 - Key headlines

Cameron Baxter, Community Safety Operational Manager, updated members on the current work of the **Community Safety Partnership**. Michelle Love, Service Director for Highways and Community Protection, will now be chairing the newly named Community Protection Partnership. The annual strategic needs analysis has been undertaken and is being analysed, priorities are expected to remain the same as 2023. 400 responses were received from a community safety survey conducted before Christmas; the results are being analysed. Following a review of Prevent on the Island, one recommendation was the implementation of a designated prevent board, which was previously an agenda item within the community safety partnership. Michelle will be the designated prevent lead for the IWC. Funding to provide face-to-face training for 80-100 individuals through the Home Office 'Preventing Radicalisation' Scheme was successful. It is now out for providers to review and bid for. The training will focus on understanding autism spectrum condition traits and behaviours and the differences between vulnerability and susceptibility, and will initially target designated safeguarding leads, deputies, public protection police and Youth Justice Service. The date, venue and final invite list will be finalised in the next couple of months. The requirement comes from a link between Prevent referrals and ASC which has been noted nationally. Michelle Love will be asked to attend the July Board meeting to present an update on the strategic needs analysis and priorities for the Community Protection Partnership.



Partnership Manager, Kelly Diamond, presented the **quarter 1 and quarter 2 2023-24 partnership data report** which had been analysed by the Performance and Quality Assurance subgroup and Executive groups in December. Some of the items noted from the report included:

- The IOW has a lower percentage of children subject to a child protection conference for emotional abuse and a higher rate for neglect compared to national figures and statistical neighbours. Members discussed whether this could be due to differences in categorising plans. The Lead Independent Reviewing Officer is working with conference chairs to review this, the outcome of this work will be reported to the PQA subgroup and IOWSCP Main Board.
- The number of children living with their family in temporary accommodation has increased 20% over the last year, and 35% over the last 2 years.
- The cumulative factors that impact on children and their wellbeing, some of which are adult mental health, adult criminality, and housing. Cumulative harm is a partnership strategic priority for 2024-26.
- Importance for all children, Looked After Children in particular, having access to and receiving dentist service.



Hampshire and IOW Police provided members with information regarding an item raised at the July Board around **children being subject to strip searches**. The HMIC have set expectations that no child should be subjected to a strip search unless it was approved by the Superintendent and in the presence of a second adult. Between January – December 2023, 74 children were brought into custody on the IOW, only one child was subject to a strip search, and this was based on intelligence. A Sergeant and Inspector reviewed the request, and it was authorised by the Superintendent. The child was offered the opportunity for their parents to be present, but the child declined

this. Same sex officers were present during the search which was a negative result. Given the very low numbers, disproportionality could not be commented on. No children were strip searched by Hampshire and IOW Police on the Island outside of custody during the same period. In order for the partnership to maintain visibility on this important area, the board will receive an annual update on the data.

Debbie Price, Children's Social Care, presented the **Children's Social Care Ofsted Inspection report**. The inspection was held over the autumn half term in October 2023. The overall rating was Good, with requires improvement in 'The experiences and progress of children who need help and protection'. Debbie Price explained what actions Children's Social Care were taking to address the areas requiring improvement. Ashley Whittaker will be asked to present an update on this at the April Board meeting. Children's Social Care were asked to consider what support the partnership could provide in raising awareness of private fostering, both identification and reporting.



Kelly Diamond presented the key points from the **IOWSCP's IOW MASH audit** undertaken in October 2023. A practitioner briefing has been developed in order to share the learning in a more accessible way for front-line staff (see page 2). The presentation and briefing have been shared with education colleagues via the education subgroup and Designated Safeguarding Leads (DSL) network and will be shared at the Headteacher Forum.

Debbie Key, Strategic Partnership Manager, provided members with a presentation that brought together learning from **Local Child Safeguarding Practice Reviews (LCSPRs)** and Case Reviews conducted across the country, rating the IOWSCP against the recommendations from these reviews. The Exploitation Subgroup, Learning Inquiry Group and Performance and Quality Assurance Subgroups have all received the presentation and will be taking relevant recommendations into consideration to strengthen work already in place and consider next steps.

Debbie Key presented to members the changes in **Working Together to Safeguarding Children 2023** which was published on the 15th December 2023, alongside a number of important government documents. Working Together will now be reviewed annually. A briefing document will seek the safeguarding partner agency leads' thoughts on the changes. A proposal on how these changes will be taken forward will go to the March Executive meeting.

Debbie and Kelly presented the paper provided to members ahead of the meeting which explained the partnership's **strategic priorities for 2024-26** (see page 2). Although the partnership was in a time of change in terms of the strategic partnership between Hampshire and the Isle of Wight, it was agreed it was important the partnership have clear direction during this time. However, these priorities can be further reviewed once the new Director of Children's Service is in post.

## IOW Safeguarding Children Partnership Strategic Priorities 2024-2026

### 1. WORKING TO ENSURE A MULTI-AGENCY FAMILY APPROACH TO SAFEGUARDING CHILDREN THROUGH THEIR ENGAGEMENT IN EDUCATION

Priority 1 widens the scope around the 2022-23 priority on understanding and responding to disrupted education of vulnerable children. There will be an emphasis on ensuring that the multi-agency workforce reflects the IOW Children's Services restorative practices approach and being transparent with families about what needs to change. The scrutiny of key education data will be expanded, focusing also on alternative provision, reduced-hours provision, electively home educated and children missing from education. Assurance will be gained around safeguarding training for pastoral staff employed by schools and settings as well as the multi-agency roles and responsibilities supporting children and families to ensure educational engagement/attendance. There will also be a drive to ensure that agencies working with children and families fully understand the universal and early help offer and can support access to this.

### 2. PROMOTING A MULTI-AGENCY, WHOLE-SYSTEM APPROACH TO SAFEGUARDING AND PROMOTING THE WELLBEING OF CHILDREN, FOCUSED ON PREVENTING NEGLECT AND CUMULATIVE HARM

This priority relates to children with multiple episodes of abuse/neglect who move between plans, e.g., Child Protection plan to Child in Need.

## Thematic Multi-Agency Audit of: Quality of referrals to the Multi-Agency Safeguarding Hub (MASH) Practitioner Briefing

This audit formed part of the IOWSCP's multi-agency audit plan for 2023/24 and examined 12 referrals to Hampshire and Isle of Wight Multi-agency Safeguarding Hub (MASH) between 1<sup>st</sup> July 2023 – 1<sup>st</sup> September 2023.

The audit examined current multi-agency practice regarding quality of referrals into MASH. IOWSCP audits are used as a window into current practice, identifying best practice and emerging themes across the cases examined where further practice development is needed.

The audit sample consisted of referrals where outcomes included:

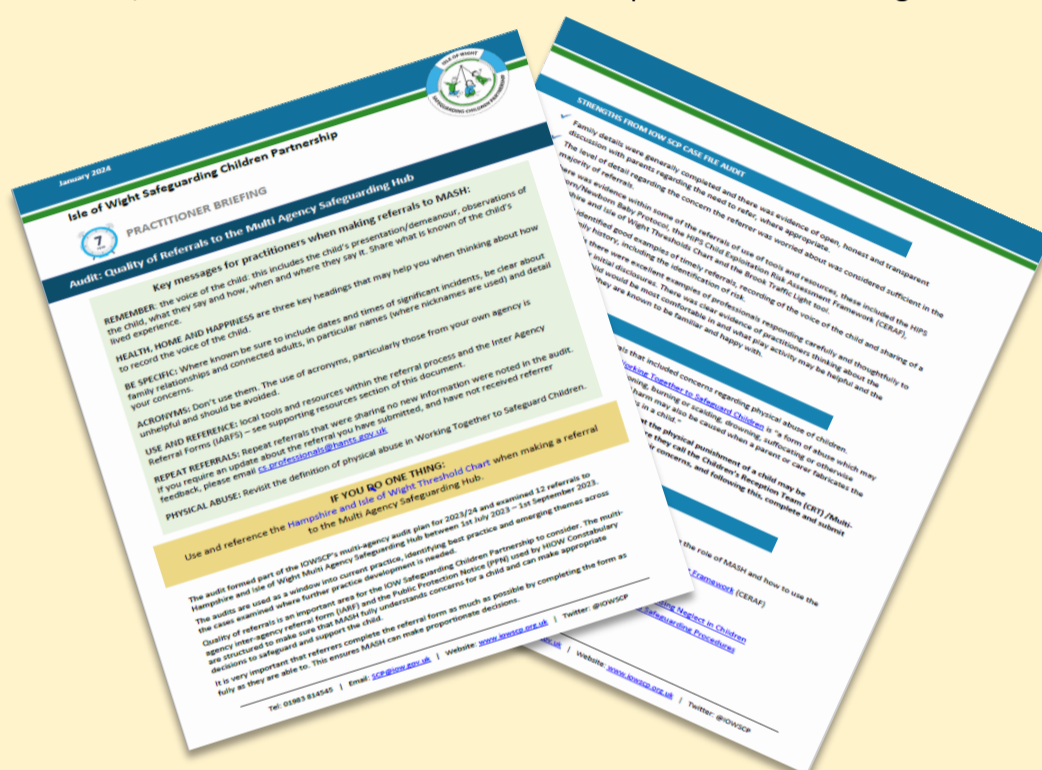
- ➔ Referral where a Section 47 enquiry was undertaken,
- ➔ Referral where a child and family assessment was recommended,
- ➔ Referral put forward for an early help assessment,
- ➔ Referral where advice and information were given,
- ➔ Referral that was closed.

A mixture of referring agencies, genders and ages of the children were represented.

There were a number of areas of effective practice identified and areas for development.

Recommendations from this audit will be monitored by the IOWSCP Performance and Quality Assurance subgroup.

A [7 minute practitioner briefing](#) has been developed in order to easily share the learning with frontline staff.



## Serious Violence Toolkit

During 2022-23 the Government introduced the Serious Violence Duty (SVD). In essence, the statutory duty requires authorities to work together to prevent and reduce serious violence in their local area. They need to understand the causes and effects of serious violence, and develop a strategic response to prevention and early intervention.

Hampshire, Isle of Wight, Portsmouth and Southampton Violence Reduction Partnership have recently launched their new Serious Violence Toolkit to support professionals working with individuals and their families impacted by serious violence in the Hampshire, Isle of Wight, Portsmouth and Southampton areas. The toolkit has been produced to support a co-ordinated approach to tackling and preventing serious violence and understanding its root causes. The serious violence duty means that all partners, statutory and non-statutory, have a part to play to reduce violence.

The toolkit contains practical tools, support and resources to assist you, and signposting to multi-agency training.

### Isle of Wight Safeguarding Children Partnership Toolkits

These toolkits are created for professionals to better understand and respond to safeguarding concerns. They contain guides, resources, case studies, strategies and training opportunities.



**Child Sexual Abuse**

The [child sexual abuse toolkit](#) supports a co-ordinated approach to preventing child sexual abuse and improve identification, protection and support for victims, survivors, and their families. It has been created to improve the ways in which children's needs and risks are understood, recognised and responded to.



**Neglect**

The [neglect toolkit](#) aims to prevent and reduce the impact of neglect and to ensure the safety and wellbeing of children and young people. It has been developed to support frontline professionals and managers who work with children and families to identify and respond to issues of neglect.

They could be living within a household where children live or with someone who has regular contact with children. This can be in any capacity (such as parent, partner, grandparents, non-family member etc.)



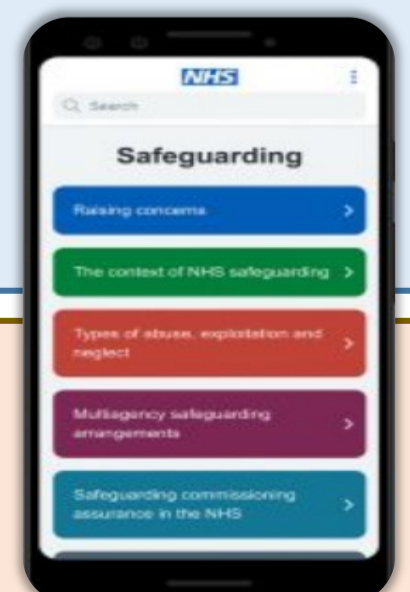
**Voluntary & Community Organisations**
