# **Safeguarding Children**

To report safeguarding concerns please complete the Inter-Agency Referral Form (IARF). In an emergency please call the Police on 999.

The <u>Isle of Wight Thresholds Chart</u> can help you identify the risks and types of services a family may need. For urgent child protection enquiries, professionals can call 0300 300 0901 (0300 555 1373 out of hours). Here some <u>FAQs</u> about the Children's Reception Team (CRT) and Multi-Agency Safeguarding Hub (MASH). Complete a <u>CPI form (Community Partnership Information form)</u> to share non-urgent information with the Police.

# Partnership Board meeting held on the 27th March 2023 – Key Information

James Seward joined the meeting to present on Project Fusion, which is a partnership project between the IOW NHS Trust, Southern Health, Solent Trust and Sussex Trust to bring together community, mental health and learning disability services. A new organisation is expected to be in place by March 2024. A clinical leadership group is working on a structure and a business case to be presented to NHS England. The benefits would include input and clinical support of partners and the changes on the ground were viewed as improvements in the provision of services which weren't previously available. Members sought assurance that the partnership would result in levelling up and not impact IOW services. James has been invited back to the September meeting to provide further update on the project.

Jim Pegler attended the meeting to present the work of the Violence Reduction Unit (VRU), which now has a central point in order to gain a more consistent approach across the whole of Hampshire and the Isle of Wight. The mission of the VRU is to prevent violence by building a collaborative, courageous and sustainable partnership which will drive the change required to successfully address the causes and consequences of violence. The small team, funded for three years, will develop a better systemic and shared approach.

An outcome report of the IOWSCP's annual audit of the Multi-Agency Safeguarding Hub (MASH) was presented. This audit forms part of the annual work of the Performance and Quality Assurance (PQA) subgroup. The audit examined current practice with regards to cases referred to CRT MASH; the assessment and decision making processes; actions taken and the outcomes reached where Neglect was the presenting factor. In addition, a staff survey was undertaken and the results analysed to inform the audit. Consideration will be given to repeating the staff survey in 2023-24, but not anonymised this time. There were a number of key areas of strength noted and recommendations agreed around referrer feedback, the Threshold Chart being updated and training development opportunities around the Neglect Strategy and toolkit; on the use of the thresholds chart and how to complete an effective IARF; MASH processes; and using the escalation policy.

A second audit report was presented, this one on the Unborn/Newborn Baby Safeguarding Protocol. The audit looked at cases where concerns for the unborn/newborn baby were raised and how the concerns were managed and responded to. It offered assessment of how well agencies working with families are using the <u>HIPS Unborn/Newborn Baby Safeguarding Protocol</u>, and the use of <u>Safer Sleep</u> and <u>ICON</u> resources to support families. Key strengths included the use of the resources and referrals being clear and timely. Assessments demonstrated analysis of the needs of the baby, risk factors, short and long term impacts of risks and the likelihood of change within the family. Positive examples of multi-agency working were noted, as well as examples of professional's persistence and flexibility in engaging parents in support. Areas for development included timely completion and sharing of pre and post birth plants/Child In Need plans and accessing and recording of supervision. Recommendations from both audits will be monitored by the PQA subgroup.

The Education Self-Assessment Audit Report 2022 was provided to members. The self-assessment requires governing bodies to carry out an annual review of their safeguarding practice. As with previous years, all Island schools returned their self-assessments. Each school is required to develop an action plan to address any gaps and to improve areas identified for development through the audit. The report is analysed through the IWOSCP Education subgroup. Recommendations from the audit included work around the expectations about challenging and reporting prejudicial language and behaviour into processes and school policies, greater awareness and understanding around child-on-child abuse, and more clarity on the whistle-blowing policy and role of the LADO Service (Local Authority Designated Officer).

Steve Crocker, Director of Children's Social Care, provided a verbal update on the care review consultation. The Government have now published their response to the review and this is out for consultation until May. It was agreed agencies would provide the Partnership Team with their responses for a joint response to be submitted on behalf of the IOWSCP. A main area of the review is a vision of multi-agency family help teams including co-location and co-alignment of services.

The review of Working Together to Safeguard Children 2018 statutory guidance is underway with the updated document expected in May. It is widely anticipated Education will become the fourth Safeguarding Partnership of Local Safeguarding Children Partnerships, however the logistics of around this are understood to still being worked on.

The Q1 and Q2 2022/23 multi-agency data report was presented to members. Key observations highlighted included:

- The percentage of Looked After Children who have dental checks up to date and within timescales
- The number of CERAFs received in comparison to the same quarters in 2021-22
- The increased rate of the number of adults assessed for mental ill health where there is a child/children in the household
- The incremental increase in the number of children seen in A&E with alleged alcohol related incidents
- The average time of referral to assessment in CAMHs being lower than the previous two quarters and the average time from assessment to first appointment is at the third lowest it has been going back over the previous 10 quarters.
- The number of care leavers being in employment, education or training remains consistently above 70%

Scott Mackechnie thanked Steve Crocker for his contribution towards the Partnership and national work in safeguarding children. Stuart Ashley, the new Director of Children's Services, will remain as part of the Board and Steph How will join the Board as the new Deputy Director for Children's Social Care. Scott also thanked Jenny Burn for her contribution to the Partnership and chairing of the Education subgroup. Martyn Beales will replace Jenny on the Board and will become the new Education Subgroup chair. We extend a warm welcome them both.

# HIPS Child Sexual Abuse Strategy and Toolkit

Hampshire, Isle of Wight, Portsmouth & Southampton (HIPS) **Child Sexual Abuse Strategy** 2023



The HIPS Child Sexual Abuse Strategy has been developed with the Hampshire, Portsmouth and Southampton LSCPS to support a coordinated approach to preventing child sexual abuse (CSA), and to improve the identification, protection, and support for victims, survivors and their families. It has been created to improve the ways in which children's needs and risks are understood, recognised and responded to at all stages.

This strategy aims to support all victims and survivors and tackle offending by recognising the complex and interconnected nature of child sexual abuse. The strategy, therefore, promotes a whole-system response to effectively protect and safe-

guard children.

The successful implementation of the strategy will be achieved through continued cultural change in which the workforce communities and families develop the confidence to 'think the unthinkable', recognise the signs that abuse might be occurring and have those brave conversations.

## The right to choose: Government guidance on forced marriage

The marriage of civil partnership (minimum age) Act 2022 came into force on the 27th February which means that 16 and 17 year olds are no longer allowed to marry or enter a civil partnership, even if they have parental consent.

It is now an offence to cause a child under the age of 18 to enter a marriage in any circumstances, without the need to prove that a form of coercion was used. This includes non-legally binding 'traditional' ceremonies which would still be viewed as marriages by the parties and their families.

# **HIPS Child Exploitation Strategy 2023-26**

A strategic child exploitation group is established across the HIPS (Hampshire, Isle of Wight, Portsmouth and Southampton) area to provide leadership and direction, ensuring a coordinated partnership response to child exploitation through the HIIPS Child Exploitation Strategy.

This strategy sets out the agreed priority areas that all partner agencies will work towards to ensure the most effective and coordinated response to

exploitation and extra familial harm. This includes recognising the need to work with our colleagues across the four local safeguarding adult boards (4LSAB) to ensure there are appropriate transitional safeguarding arrangements in place to support all victims of exploitation.

This strategy should be read in conjunction with relevant safeguarding procedures which can be found on the HIPS Procedures website and with relevant LSCP strategies and toolkits, including the HIPS Child Sexual Abuse Strategy and toolkit.




**CPI Form (Community Partnership Information) Guide**
