# ISLE OF WIGHT SAFEGUARDING CHILDREN PARTNERSHIP (IOWSCP)



All organisations that work with children and families have a shared responsibility to safeguard children and to work together to do this. On the Island the Isle of Wight Council, Hampshire and Isle of Wight Integrated Care Board, and Hampshire and Isle of Wight Police work together as Safeguarding Partners to protect children on the Island in a formal arrangement called the

#### Isle of Wight Safeguarding Children Partnership

Safeguarding children is everyone's responsibility and the Partnership's ambition is that everyone can recognise and respond to ensure that children, young people and their families are effectively safeguarded and supported.

#### Safeguarding assurance through transformation

Children's Social Care: The Multi-Agency Safeguarding Hub (MASH), Local Authority Designated Officer (LADO) and Out of Hours services are being delivered through a service level agreement with Hampshire until the 31<sup>st</sup> January 2025. Option appraisals are being developed for these services and in May a feasibility survey on the preferred option will be undertaken. These changes also include the educational psychology and school improvement services. The IOW education strategy will be published by the end of the summer term, a key part of the transformation will be around provision for children with special educational needs and disabilities (SEN&D) and pupil places. The reduction in the child population means consideration of the number of primary school places required. These changes should, in the longer-term, drive-up education outcomes for Isle of Wight children.

Isle of Wight some of the challenges of providing health services for a small island community and to maximise the productivity and efficiency of services.

In 2023 they strengthened their partnership with shared leadership across the two organisations. This closer working allows them to make best use of local resources, manage demand and capacity, tackle unwarranted variation, improve care pathways and identify opportunities to align back-office functions.

**Project Fusion:** The creation of the new Hampshire and Isle of Wight Healthcare NHS Foundation Trust will take place on the 1st July 2024, bringing together community, mental health and learning disability (CMHLD) services across Hampshire and the Isle of Wight. They are working to a principle that patients should not notice a difference following the creation of the new Trust. The plan is to be completed in phases. The Isle of Wight CMHLD services transferred to Southern Health on the 1st May 2024.



#### **Scrutiny**

Progress on the Isle of Wight Children's Social Care Ofsted Inspection Action Plan was provided. The partnership has offered it's support in progressing this. Regular updates will be received at each Board meeting.

The annual 157/175 Safeguarding in Education self-assessment audit report was presented, which brings together analysis of every Island school's self-assessment in meeting their safeguarding requirements, as set out in <a href="Keeping Children Safe">Keeping Children Safe</a> in <a href="Education">Education</a> statutory guidance. It is a statutory requirement for schools to carry out an annual review of their safeguarding practices and to provide assurance to the local authority and LSCP. The IOWSCP Education subgroup received the audit report and will be monitoring learning and themes identified.

The IOWSCP's thematic case file audit on the **Multi Agency Response to Child Sexual Abuse report** was presented. The audit was commissioned by the PQA subgroup as part of the IOWSCP strategic priorities for 2023-24, focusing on the implementation of the (HIPS) Child Sexual Abuse Strategy and associated toolkit launched in March 2023. Analysis was considered alongside LCSPRs published in other local areas, a frontline staff survey and national learning, such as the Independent Inquiry into Child Sexual Abuse in 2022 and the JTAI Inspection in 2020. A number of areas of strength and good practice were identified, including proactiveness and tenacity of multi-agency practitioners and perseverance in establishing relationships with children and families. Recommendations have been developed in order to address areas to strengthen practice, these will be monitored by the PQA subgroup. Further details on the audit can be found in the practice briefing on Page 3.

Anna Clark, Lead Independent Reviewing Officer presented findings from the **child protection conference audit**. The audit report was presented to the Partnership Board to discuss multi agency attendance at statutory meetings and to enable effective decision making around risk to children and families. Members discussed which agencies saw a dip with information being provided, why these results may have occurred and how agencies can be supported to improve responses. The report has already been presented to the IOWSCP's PQA subgroup and will also be taken to the education subgroup for further exploration and discussion.

A second part of the report looked at **child protection conference categorisations** which arose from questions raised through the PQA subgroup's data report analysis. The report details a snapshot of data from the last 6 months. Agencies are seeing a greater level of complexities with families and are reminded that consideration should be about what the most prominent concerns are, children and families need to clearly understand the risks and concerns. Professionals are reminded that they can challenge the child protection conference categorisation.

The **IOWSCP business plan for 2024-26** was presented. The first Safeguarding Practice Week is provisionally set for June, and will be considering Learning from Reviews. The Partnership Team will be looking for support from partner agencies to promote this. A review of the neglect strategy and toolkit is underway.

#### The IOWSCP Strategic Priorities for 2024-26 are:

- 1. Working to ensure a multi-agency family approach to safeguarding children through their engagement in education.
- 2. Promoting a multi-agency, whole system approach to safeguarding and promoting the wellbeing of children, focused on preventing neglect and cumulative harm.
- 3. Embedding the changes in Working Together to Safeguard Children 2023.
- 4. Embedding and refining the work of the partnership.

# "I have the right to be protected from child sexual abuse"

The Convention on the Rights of the Child: The children's version

15% of girls and 5% of boys will experience child sexual abuse before the age of 16.

Only 1 in 8 will become known to professionals at the time.



Research consistently estimates a considerably higher number of children may have been sexually abused compared to the number of children who disclose.

The Centre of Expertise on Child Sexual Abuse conservatively estimates that half a million children every year in England and Wales will experience some form of sexual abuse. In their report Child Sexual Abuse in 2022/23: Trends in Official Data they state that "Ultimately this means that the gap between the number of children being sexually abused and the identification and response by statutory agencies remains far too wide".

This is coupled with learning from the Independent Inquiry into Child Sexual Abuse 2022 (IICSA) which highlighted that many adult survivors shared that they did try to say what was happening to them as children, in actions, if not in words but they were not heard.



# **HIPS Child Sexual Abuse Strategy**

In March 2023, Hampshire, the Isle of Wight, Portsmouth, and Southampton (HIPS) LSCPs launched the <u>HIPS Child Sexual Abuse Strategy</u> and associated toolkit. The strategy was produced to support a coordinated approach across agencies within the HIPS area to prevent child sexual abuse and improve the identification, protection, and support for children and their families.

It's creation is to improve the ways in which children's needs and risks are understood, recognised, and responded to at all stages.

It is not a "stand alone" document and should be considered alongside other relevant HIPS/LSCP strategies, in particular the HIPS Child Exploitation and Extra Familial Harm Strategy.

## **HIPS Child Sexual Abuse Toolkit**

The <u>HIPS Child Sexual Abuse Toolkit</u> contains lots of information and resources for all professionals working with children, young people and their families.

It breaks down what child sexual abuse is and the different typologies, including harmful sexual behaviour. It has resources to help with the identification of child sexual abuse and reporting process if abuse is suspected or a disclosure is made. It details the assessments needed to ensure the safety and wellbeing of a child who has been sexually abused. There are resources and guides to support specific groups that require consideration around interventions and support and the three stages of prevention are explained.

## **CSA Signs and Indicators template**

Within the Toolkit you'll find the CSA Signs and Indicators template.

This excellent resource has been created by the Centre of Expertise on Child Sexual Abuse for use by professionals working with children and families.

It's designed to provide a common language amongst professionals to discuss, record and share concerns that a child is being, or has been, sexually abused.

'It simply isn't likely that a child will feel able to tell us directly what is happening. The responsibility is on us: to gather the signs and indicators of possible abuse, build a picture of our concerns and the child's experience and work out what to do about them.'

# **Practitioner Briefing: Child Sexual Abuse**

In 2023 the IOWSCP undertook a thematic audit to consider the Isle of Wight multi-agency response to child sexual abuse. The audit formed part of the work within Priority 1 of the IOWSCP Business Plan 2023-24.

Thematic audits are used as a window into current practice, identifying best practice and emerging themes where further practice development is needed.


The aim of this audit was to provide a broad overview of current work taken to support children at risk of, or who have suffered, child sexual abuse.

The results of the audit and a frontline practitioner survey, were considered alongside national research.

The audit identified many multi-agency practice strengths.

<u>A practitioner briefing</u> has been created to share the learning from the audit with frontline staff, as well as resources, and key messages for practitioners to take away, and specific key message for strategic leads and managers.

**STOP** SAFEGUARDING THEME OVERVIEW PACKS

To support the IOWSCP in preventing child sexual abuse, and improving the identification, protection, and support for victims, survivors, and their families, we are excited to introduce our <u>Child Sexual Abuse Safeguarding Theme Overview Pack (STOP)</u>

This pack is designed as a one-stop resource to assist professionals and parents and carers to prevent, identify and respond to child sexual abuse and to help keep the Isle of Wight's children safe.

This pack include pages that agencies and schools can share directly with parents and carers.

STOP Pack:
Child Sexual Abuse

The <u>Joint Targeted Area Inspection report of the multi-agency response to child sexual abuse within the family environment</u> was published in February 2020.

The report states that child sexual abuse in the family environment needs to be a priority across government departments and local areas. "Too often, responses leave children repeatedly victimised, perpetrators unidentified, who therefore remain a risk to children, and known victims not supported well enough."

The conclusion referenced the role communities, organisations and the media have to play and the need to create an environment in which children and adults are able to talk about sexual abuse more easily.

The conclusion to the JTAI report is powerful and essential reading for all involved in the protection of children. It says:

"In conclusion, we can no longer stay silent on this issue. We have to talk about it and act. Everyone needs to play their part in identifying, preventing and tackling child sexual abuse in the family environment."

### **Domestic Abuse**

On the Isle of Wight, it is estimated that 4,300 females and 1,720 males over the age of 16 were subjected to domestic abuse in 2022. Women were twice as likely than men to be a victim-survivor of domestic abuse flagged crime and 37% of domestic abuse flagged crimes had an ex-spouse or ex-partner relationship.

The Domestic Abuse Act 2021 recognised children as victims in their own right for the first time. This is a crucial step forward. All victims and survivors, including children, should receive the support they need when they need it.

The training offer from the IOW Safeguarding Children Partnership will assist in not only recognising and understanding domestic abuse, but to play a role in addressing it. Courses are FREE to professionals working with IOW children and families.

#### → An Introduction to the Impact of Domestic Abuse on Children and Young People

This course offers an introduction to the impact that domestic abuse can have and will explore some of the physical and emotional effects. It will help to upskill professionals to feel more confident in responding to a disclosure or suspicions of abuse.

#### **→** Coercive Control Awareness

The use of Coercive and Controlling Behaviour (CCB) within an intimate or family relationship is a criminal offence in England and Wales. This session will support professionals to better understand the dynamics of coercive control, equip them to spot the signs of coercion and enable them to relate this to risk.

**→** Responding Well to Disclosures of Domestic Abuse

This event is provided by Stop Domestic Abuse and will help professionals deal with a disclosure sensitively and effectively.

## Designated Safeguarding Leads (DSL) Conference

Bookings are now open for the HSCP and IOWSCP Designated Safeguarding Leads Conference on the 18th June 2024.

The conference is designed to support those in the role of Designated Safeguarding Lead (DSL) in engaging with a child-centred, multi-agency response to safeguarding concerns. It will focus on the role of DSLs in supporting and building school engagement for all pupils, with a "support first" approach. It will explore how this approach is informed by an understanding of the child's lived experience and their wider context. Themes covered during the day will include identifying and supporting young carers, child-on-child abuse and the role of schools in supporting the mental health of children and young people

Delegates will hear important updates regarding statutory guidance including the Prevent Duty, referral pathways and the Hampshire and Isle of Wight Safeguarding Children Partnerships Threshold Chart. Important information will also be shared regarding recent local learning from case reviews and audits, as well as new tools and resources designed to support professionals working in schools across Hampshire and the Isle of Wight.

Following on from the success of previous DSL conferences, this year's event will be held virtually on MS Teams. **Providing a delegate attends the whole day, this conference will satisfy the statutory refresher training for DSLs, as identified in KCSiE 2023.** The event is open to all DSLs across Hampshire and the Isle of Wight early years settings, schools and colleges.




