## **Guidelines for Applicants**

The Historic Gardens Foundation (HGF) will offer grants towards publication of material relating to historic parks, gardens, and designed landscapes. Grants are available to charities, other public interest organisations and, in exceptional cases, individuals, who are pursuing aims similar to those of the HGF. Preference will be given to projects with an international dimension and to Applicants who have worked with the HGF in the past. The grants are not confined to the UK and Applicants can be from any country.

The HGF's resources are modest: preference will therefore be given to helping smaller organisations which often find it difficult to raise funds. In general, the trustees will only consider applications up to  $\pounds 1,000$ .

## What the HGF will fund

The HGF is an educational charity whose remit is to promote the cause of historic parks, gardens and designed landscapes worldwide by means of communicating information and raising awareness of our garden heritage. A fuller statement of our objectives and our work can be found on the HGF website <u>www.historicgardens.org</u>

What the HGF is looking for are projects, preferably linking two or more countries, to support garden heritage by means of a publication, including in hard copy form. The publication must be in English or carry a summary in English. Grants are not intended to fund physical projects such as the restoration of a park or garden, or designs or management plans.

#### How to apply

Forms should be completed in English and sent to the HGF (details on the form). Applicants must state the main elements of the cost of the project for which funds are being sought. The HGF is a small charity, therefore it is not possible to provide detailed feedback on unsuccessful applications.

#### Grant decisions

In January, April, July and October the Grants Committee will consider all valid applications received before the first of that month. Decisions are at the entire discretion of the Committee and all decisions are final. Decisions will be notified within the subsequent four weeks. If awarded a grant, it is a condition that Applicants will report on the use made of it within six months of receipt and that the HGF is appropriately credited in the relevant publication. Awards will be announced on the HGF website.
