### **Project Overview**

A leading international Law firm selected Elite 3E as the Practice Management solution which would enable them to achieve their key strategic objectives.

### **The Solution**

Particular challenges were faced; time and geographical constraints.

A particular concern of the client was the impact to the business of lost productivity both as a result of the time needed to upskill their people and Globaltech Solutions adopted a flexible approach where objectives would be achieved with minimum downtime to normal business operations.

This involved the development of a 'blended learning solution', which incorporated instructor-led training; online support via e-learning modules, continuous access to FAQs & virtual training sessions via the online Learning Guide; and support with internal communications to help manage the change process.

The learning program was executed in two phases. A e-learning course and assessment focusing on SAP overview and navigation. This was also tied into a LMS to ensure all results could be reported on.

Phase two focused on the classroom training and involved reviewing the course content to ensure the correct message was being delivered for the whole organisation. This course focused more on the engagement management process within the SAPphire Netweaver portal.

The new training program started in January 2010 and has greatly increased the number of employees trained in the first 6 months of the year compared with previous years.

The incorporation of the e-learning and Learning Guide solutions have enable the employees to manage their own learning program whilst spending less time in a formal classroom environment.
