What projects will be considered?

They may include educational schemes, sporting projects, regeneration & renovation or skills development. We will judge each application individually, so long as you operate a not for profit organisation your application will be considered.

Who can apply?

As mentioned above any not for profit organisation will be considered. Grants will not be awarded to individuals or companies who aim to generate profit.

After you submit?

Once we receive your application we will send you acknowledgement via email. Your application will then be reviewed by a panel comprising of NWP representatives and an independent party. Please note you may be required to provide more information regarding your application.

After your application has been reviewed we will write to you to inform you whether your application was successful, and the amount of money awarded to you. If you are successful we will write to you to arrange payment of the grant.

We will then contact you after a period of 12 months to monitor progress of the project. You will also be asked to complete an end of grant questionnaire to provide us with information on how the grant has helped improve your community.

- All grants must be spent within 12 months of the notification letter and failure to present evidence of expenditure may result in the withdrawal of funding.
- In accepting a grant you will agree to take part in any promotional or publicity activity relating to the NWP Community Fund, and to acknowledge the grant publicly as appropriate and as practical. In addition you will also agree to complete an end of grant form and provide any further information requested during the funding period.
- Any misrepresentation, including concealment or withholding of relevant information, by the recipient in its application for a grant may be treated as a failure to comply with these terms and conditions.
- As a recipient of an NWP Community Fund grant you will agree to act in accordance with any statutory obligations that may apply to your organisation.
- You will also ensure that you have an equal opportunities policy and if the project involves work with children, young people or other vulnerable groups you will also have a protection policy, to comply with all relevant laws and good practice throughout the period of the grant.
