Frequently Asked Questions

How laser tattoo removal works

Laser tattoo removal works by breaking up the ink particles that are in the skin. In traditional lasers, such as Q-switch, photothermal action is delivered to the pigment of the tattoo, as well as the surrounding tissue, to break up the ink particles into smaller particles. These smaller ink particles are much more easily removed from the body through the immune system.

Is laser tattoo removal painful?

The treatment causes clients minimum discomfort, the sensation varies but is often described as a 'flick of an elastic band'. We ensure that all discomfort is minimized for our clients, and we offer cold air cooling and topical numbing cream to clients to numb the area affected. Any pain relief treatment options can be discussed with your aesthetician.

When will I see results?

At FRESHINKSTUDIO1 we use Q-Switched Nd:YAG Laser tattoo removal, as it is up to 3-4x faster than the previous generation of lasers – the Q-switched laser technology. How fast you will see results depends on the colour and complexity of the tattoo, as well as other factors such as age, skin type and the chemical composition of the tattoo. The depth and density of the ink can also affect the speed of results. During your consultation your aesthetician will give you an estimate of how many treatment sessions will be required to remove your tattoo. However, on average Q-Switched Nd:YAG Laser removes a tattoo in 4 sessions. We firmly believe that in any like-for-like comparison of blue, black or dark blue tattoos, Q-Switched Nd:YAG Laser tattoo removal offers the best treatment option for you.

Are there side effects?

Q-Switched Nd:YAG Laser is known to be the safest laser tattoo removal option around at present. At FRESHINKSTUDIO1, we use Q-Switched Nd:YAG Laser – which break down the ink particles through photomechanical effects – in order to ensure that the risk of any scarring is significantly reduced. Q-Switched Nd:YAG Laser typically does not leave scars. As with all medical procedures, there is still a small chance of potential side effects, including; Temporary blistering – which is a common side effect of tattoo removal. However, it is temporary. Erythema, bleeding, crusting and scabbing- a clean dressing and suitable healing ointments are recommended if this occurs Wheal/flare with erythema may last 2-4 hours. Mild to moderate itching Pigment changes - both hyperpigmentation and hypo pigmentation are possible, however this should be temporary and last 2-6 months. In most

cases, there are no side effects and the above potential side effects are limited to a small fraction of all treatments that are carried out.

How long does one treatment take?

This will vary depending on the size of the treatment area, and client's tolerance throughout treatment. It could be just 10 minutes, but for much larger tattoos we may need 1 hour.

Are you looking to get a tattoo removed? Before you do, READ THIS ARTICLE...

Tattoo removal has always been a difficult and painful process, and far from perfect. Modern techniques are better, but still don't work perfectly. The modern techniques use lasers to break down the inks beneath the skin, allowing them to be dispersed into the body. Before lasers were developed to the level this was possible, only more destructive methods were available. Most of these involved removing layers of skin, down to the point the tattoo inks were removed with them.

They included dermabrasion, removal with acids, cryosurgery, or simply cutting them out. For larger tattoos, this could require skin grafts, clearly a far more painful and risky procedure than tattooing itself.

Tattoo removal lasers, on the other hand, are non-invasive...

They target the absorption spectra of particular pigments, which heats them and disrupts their physical structure. Because they're dependent on light absorption, black and other dark colors are the ones most easily removed.

On the other hand, brighter colors, in particular bright yellows, greens, and fluorescents, are difficult to remove with lasers, and true removal of these colors can require one of the more archaic methods. Alas, even though lasers are non-invasive, this does not mean they are harmless. They can cause scarring, still, and a topical anesthetic is usually applied, as they can be painful, too. The temperatures produced during laser tattoo removal can cause burns to the skin.

Easy Tattoo Removal How does the laser treatment work?

What laser treatments, do, essentially, is accelerate the process that would normally occur over time with sun exposure. Tattoo colors are created with suspended pigment particles in the skin. These particles are too large for the body to absorb, which is why they stay in place beneath the skin. The lasers target these particles directly, breaking them into smaller pieces that the body can then absorb. Sunlight has a similar effect, but it's much slower. Unfortunately, speeding up the process requires hitting the skin with enough energy to be harmful.

How many visits are needed?

It will take several visits to actually remove a tattoo, and each must be spaced at least four weeks apart to allow for healing and avoid permanent harm. As treatments progress, the spacing between them may become even longer for safety, and to give the pigments time to disperse to see where more treatments are actually needed. Tattoos on bony, thinner-skinned areas, such as ankles, will often take longer, in part because the laser operators have to be more careful in those areas.

Success will depend on several factors, some under the patient's control, some not...

Adequate hydration and overall health, particularly immune health, are important. Natural skin pigmentation also affects success, since natural pigments can absorb some of the energy intended for the tattoo pigments. Side effects are possible, too, based on some of the same controllable factors. In particular, scarring is rare, and usually occurs when there has been improper aftercare. Less predictable are side effects such as skin discoloration, where the skin gets darker or lighter permanently after tattoo removal. Skin getting permanently lighter is more likely with darker-skinned individuals.

Another possible consideration, even with tattoos that appear to be removed perfectly, is the fact that the intended mechanism of tattoo removal, allowing the body to absorb the pigment particles, could be risky. Some pigments are made from particles of known toxic metals, such as lead. Laboratory experiments have shown that it is possible that exposing the pigments to the laser energy in an organic context could cause the formation of further toxic compounds, although this has never been shown to actually occur in a living person.

What does it cost?

The average cost of removing a tattoo is around £500. You'll need to be prepared to buy aftercare products, like antibiotic cream. You need to be prepared, with some pigments, for them to get worse before they get better. Tattooed lip and eyeliners, for instance, can get darker after treatment, although this will eventually go away through treatment. It is a difficult, somewhat painful procedure with some risk of side effects. That said, it is far superior to the alternatives. It is superior to the methods of the past, in terms of both effectiveness and risks, although it does have some limitations which might cause you to use the other alternatives if you are truly determined to get rid of them. In any case, it's certainly better than the dubious tattoo removal creams out on the market.

Piercing Regulations

Having a tattoo or a body piercing is a big decision, and in a lot of cases, a permanent one. Until recently, the laws applying to tattoos and body piercing were sketchy to say the least, and it could be hard to tell who was reputable and who to avoid.

What Laws Apply to Body Art?

The main areas of law that relate to body piercing and tattoos cover the health, safety and licensing of any premises that carries out 'cosmetic' skin piercing and permanent tattooing. These laws are: The Health and Safety at Work etc Act (HSWA, 1974) The Local Government (Miscellaneous Provisions) Act 1982 (recently amended by the Local Government Act 2003) Laws relating to Age and consent The Tattooing of Minors Act 1969 Assault implications The Prohibition of Female Circumcision Act

(1985) Anaesthetics - The Medicines Act (1968) Legal exemptions affecting some special treatments. Who has to be Registered? All businesses that carry out ear piercing and permanent tattooing must be registered under the Local Government (Miscellaneous Provisions) Act, and since 2004, local authorities also regulate salons and other businesses that carry out body piercing, and semi-permanent skin-colouring techniques such as micropigmentation, semi-permanent make-up or temporary tattoo services. Local authorities have the powers to inspect any premises that carry out piercing or tattooing, and make sure that they are observing local byelaws that relate to the hygiene of their premises, staff and equipment.

How Old Do I Have to Be?

There is no legal age of consent for body piercing, and so it's legal for someone under the age of 18 to have a piercing as long as they have consented to it. Children under the age of 16 can't legally consent to a genital (or in the case of girls, nipple) piercing, as it's considered to be indecent assault. There are no plans to introduce an age of consent for body piercing in any areas other than the genitals, although some local authorities have introduced recommendations about the ages at which a person can have specific body piercings. The Tattooing of Minors Act 1969 makes it illegal for anyone to tattoo you if you are under the age of 18 - although the offence is with the person who carries out the procedure, rather than the person who asks for the tattoo. New guidelines suggest that a tattoo artist should ask to see proof of age and record this before agreeing to tattoo you.

What Must I be Asked?

Before a piercing or tattoo is carried out, the studio should, by law, ask some important health questions, as well as making sure you have all the appropriate aftercare advice. They should ask you about any allergies or health problems that may affect your tattoo or piercing, and they are also obliged to keep detailed records of this consultation for up to two years. This protects you as a client, as it makes sure that the piercer or tattoo artist knows in advance whether there are any issues that could lead to complications - or even be dangerous for you.

Aftercare Advice?

After you've been pierced, or your tattoo is complete, you should be given specific advice about what to expect, and how to look after your new artwork. Local authorities will expect businesses to give out basic advice, mostly relating to hygiene, for example the time you can expect to wait before the wound is fully healed, how to keep the piercing or tattoo clean and dry and avoiding infection.

The laws have been tightened up considerably in recent years, following horror stories about underage tattoos and body piercing that has led to septicaemia. At least with the stricter regulations, you should be assured that anywhere you visit has been registered with and inspected by health and safety officers. If they aren't registered - leave well alone. If you do decide to have a piercing or tattoo make sure you find a Reputable Tattoo Parlour and if you are un-sure about the parlour always make sure you ask to see a copy of their certificate to before any work is carried out. for any more detail please contact on us on 07459664550. we are more than happy to answer any of your question and query's.
