Wish Skin Clinic will only introduce new PROVEN treatments and procedures under full available legislation, ensuring the staff are fully trained and conversant with all aspects of the treatment, outcomes and side effects, to ensure the best possible outcome for all patients. Each client will be given full information on each treatment and/or course of treatments they are planning. This covers: what the actual treatment consists of, outcomes, contra-indications, side effects and what the patient can expect pre, during and post treatment.

Wish Skin Clinic believes in treating all patients in a confidential manner and no information obtained is divulged to any other person or organisation unless patient consent is obtained.

Wish Skin Clinic is committed to improving standards, therefore patients are encouraged to discuss with their clinician their care, understanding of the procedure and the outcome of their treatment. Feedback questionnaires will be made available to patients, which will be evaluated and will be used to maintain or improve the quality of care provided during our monthly meetings.

Wish Skin Clinic is committed to dealing with all complaints received seriously. We aim to resolve potential problems effectively and efficiently and have a Complaints Procedure in place. Wish Skin Clinic aims to provide their patients with a quality service, striving at all times to improve their standards of care.

To maintain the dignity and privacy of patients during their visit to Wish Skin Clinic, we have a private consultation and treatment room fully equipped to provide a comfortable and relaxing experience for our clients. Further facilities at our establishment include a waiting area and WC for clients and staff. A sample of the cost of treatments, including the consultation fee, are below, a full price list is available at the Clinic. Your treatment operator will confirm with you the costs of your treatment following the consultation.

All patients will be made aware of the length, number and cost of treatments before treatment begins. Payment can be made either by cash, debit or credit card and will be in 2 instalments, £25 deposit at the time of consultation and outstanding balance due on the treatment visit.

Consultations are mandatory for any patient considering one of our treatments. An appointment for consultation is made, either by phone or in person. A full consultation is given in private in our treatment room. The patient is under no obligation to proceed with the treatment and is encouraged to ask questions about their treatment and follow up advice. During consultation the clinician will gain an understanding of the patients specific needs and problems and advise accordingly whether the treatment sort is appropriate to the patient. A test patch is also mandatory and will be carried out at least 7 days before the commencement of treatment. Parental consent is required for any patient under the age of 18. Treatments for under 18's will be strictly monitored to ensure they are appropriate for that patient. We do not offer laser treatment to any person under the age of 16 years.

Should a patient have a complaint about the service provided we would like them to speak directly to our clinicians immediately in order to rectify the situation at the time of the treatment. If the patient wishes to take the complaint further then they should ask to speak to the Registered Manager, Mrs Laura Morris and put their complaint in writing.
