
Sussex IFCA is sharing the attached information on welfare programmes available to you and your families in the present exceptional circumstances.



## COVID-19: SUPPORT AVAILABLE TO FISHERMEN

In the light of the COVID-19 pandemic and its impacts on the UK's fish markets and supply chains, **a wide range of welfare support is available to fishermen** who have been affected by the outbreak.

With fish markets and restaurants closing across the country, fish prices in many areas have dropped dramatically, while overseas supply routes have also been closed-off. This presents unprecedented challenges for the fishing industry and the individuals and families it supports.

Despite this there is a wide range of funding, financial pastoral support available to fishermen and their families in these challenging times. There are numerous charities able to provide information and assistance covering issues including access to universal credit, mental health and wellbeing and signposting towards the numerous agencies able to help in these times.
