- 6. the headings and sub-headings do not form part of this privacy policy.

## Scope of this privacy policy

2: This privacy policy applies only to the actions of S&G IT Solutions Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

## Data collected

3. We may collect the following Data, which includes personal Data, from you:

- 6. in each case, in accordance with this privacy policy.

## Our use of Data

5: We will retain any Data you submit for 1 month.

6: Unless we are obliged or permitted by law to do so, and subject to any third party disclosures specifically set out in this policy, your Data will not be disclosed to third parties. This includes our affiliates and / or other companies within our group.

7: All personal Data is stored securely in accordance with the principles of the Data Protection Act 1998. For more details on security see the clause below (Security).

8: Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:

- 1. improvement of our products / services;
- 2. transmission by email of promotional materials that may be of interest to you;
