## When Two Pandemics Collide

Evidence is growing that people with an underlying condition of diabetes are the most at risk of death from Covid 19 and that 1 in 10 patients die within a week.

As the virus has made its way around the world the amount of data and number of studies have grown. They show the mortality rates from Covid 19 among people with diabetes are the highest. The data comes from China, Italy, the USA and the UK all suggesting that individuals with diabetes have an increased risk of developing more severe cases of COVID-19..

In the UK nearly a third of deaths in hospital from Covid 19 were people with diabetes as the underlying condition, while a French study found one in ten coronavirus patients with diabetes died within the first seven days of hospitalization, and one in five needed a ventilator to breathe.

## Risks for People with Diabetes

In an NHS study conducted with Imperial College London people with diabetes were found to be twice as likely to die from Coronavirus as those without it. It also found that those with Type 1 were three and a half times more likely to die.

PDGN Secretary General Adrian Sanders says these findings are very frightening for people with diabetes and should be a concern to those who handle health care budgets:

"As yet there are no studies to show people with any particular type of diabetes suffer more than any other, but the fact that those with

the condition take up so many hospital beds and will require long-term support if they survive must be a worry for everyone.

"Too many Governments are treating this as two separate pandemics with diabetes on hold while Covid 19 is addressed. We need our Parliamentarians advocating to ensure their Governments recognise this as two pandemics colliding and to not take pressure off one thinking it assists with confronting the other."

### Health Care Disparity Evidence Grows

Appalling disparities in health care have been revealed in several recent studies that the Covid 19 pandemic has magnified.

The 'Center for American Progress (CAP)' has pulled together research from across the USA showing that it is home to stark and persistent racial disparities in health coverage, chronic health conditions, mental health, and mortality.

The research claims that these disparities are not a result of individual or group behaviour but decades of systematic inequality in American economic, housing, and health care

systems.

Persistent inequities have been identified facing African Americans or Black Americans, Hispanic Americans or Latino Americans, Asian Americans. Native Hawaiian or other Pacific Islander Americans, and American Indians or Alaska Natives.

The CAP believes

that to meet the challenge of these health disparities will require a deliberate and sustained effort to address social determinants of health, such as poverty, segregation, environmental degradation, and racial discrimination.

#### Not Just the USA

In the UK Black and Asian people may be at greater risk of severe illness from Covid 19 because of social, cultural and biological reasons, experts have suggested.

Data on patients with confirmed Covid-19 from the Intensive Care National Audit and Research Centre (ICNARC) shows that ethnic minorities are over-represented compared with the general population.

Studies also show people with South Asian backgrounds have a higher

prevalence of diabetes and heart disease, which are two of the health conditions that puts people in the higher risk categories for Covid-19.

"They must take the link seriously not just in the hopefully short-term while Covid 19 is in circulation, but permanently, and to recognise that people from South Asian and black African and Caribbean

descent have a higher risk of becoming diabetic," Sanders concluded.

Advocacy Action: Ask your Government about the number of people with diabetes who have or had Covid 19? Ask what action they are taking in light of the link between diabetes and Covid 19?

## Australia Advocacy Success

Advocacy action by

Parliamentarians and patient groups in Australia has brought results. The Government has announced the Type 1 Diabetes Management in Schools program will commence in early 2020, in readiness for the new school year.

This 6 million Australian Dollar initiative will support students with type 1 diabetes by providing a training and education program for staff at selected schools, to support students with the condition.

Staff at selected schools will be trained in glucose monitoring, insulin administration and recognition of hypoglycaemia.

In addition, a new online portal will be available to all parents, principals, school staff and health professionals that will provide

access to a range of tools to help schools better understand how to support students with type 1 diabetes while at school.

#### **Covid and Diabetes**

In the Scottish Parliament, David Stewart MSP made use of his position to ask questions about the correlation between deaths from Covid 19 and people with diabetes.



Joe FitzPatrick (SNP), the Minister for Public Health's reply was: "We know that this is a worrying time for people who live with diabetes. Their safety and the continued provision of care and treatment remain a priority for the Scottish Government and NHS Scotland. Our analytical partners across the Scotlish Government–National Records of Scotland, Public Health Scotland and the national health service–are

working together to consider how we can better understand the impact of Covid-19 on people in Scotland with diabetes and other health conditions.

We will be guided by the evidence from that work in assessing any continued risk from the virus, but I encourage anyone who has any concerns about their diabetes—or any other condition—and Covid-19 to contact their general practitioner or the diabetes clinical team, who are best placed to provide specific advice and support."

<u>David Stewart: "Research by NHS England a few weeks ago concluded that one in four coronavirus deaths in hospitals were of people who had diabetes".</u>

<u>Joe FitzPatrick: "NRS published data on 22 May as an ad hoc step, which I hope folk will find useful. It showed that, in 15 per cent of all deaths resulting from cases of Covid-19 in Scotland, the death certificate mentioned diabetes. We are still learning about the virus, and it is really important that we record all such data. The Scottish Government and NRS will publish the data as it becomes available. I hope that that information is roughly what the member was looking for".</u>

#### Help from Al

Artificial Intelligence 'could help identify future diabetes patients'. Scientists have developed a new technology that uses artificial intelligence to predict whether a patient will develop diabetes. The preliminary research, which is yet to be published, applies a method known as machine learning to assess the risk of a person developing the lifelong condition that causes high blood sugar levels.

#### Diabetes Cost Evidence Grows

#### Type 2 Hidden Illnesses

Further evidence of the costs, human and financial, comes from a study into the hidden illnesses of people with diabetes.

According to the conclusions of Manchester University research, millions of people are at risk as over three quarters of people with Type 2 diabetes suffer hidden illnesses like schizophrenia and other mental health conditions.

#### **Higher Mortality**

The higher mortality associated with poorly controlled type 1 and type 2 diabetes could produce a loss of 6 million life years in the UK, according to a study by Manchester data scientists. A Medical Xpress study calculated the loss in life years from early mortality of a diabetes diagnoses. The team behind it also estimated that Type 1 and type 2 Diabetes patients with poor blood glucose control of greater than 58mmol/mol will lose around 100 life days.

#### New Statesman

PDGN was invited to participate in a global policy forum on the remaking of the world after coronavirus, organised by the New Statesman magazine. With contributions from the EU Commission, WTO, International Rescue, Parliamentarians and



Mayors from the US, UK and Greece and the former Archbishop of Canterbury.

Take home points included the need to break the power of corporations to encourage innovation and new enterprise, how environmental factors affect health and health outcomes, how locally managed health care systems tend to be the most effective, how nursing is undervalued, and how global problems require global solutions.

as a panellist to the Economist Intelligence Unit's Expert Panel Meeting on Vertical Integration in Diabetes. PDGN Co-Chair, John Bowis OBE, was also on the panel.

Data was a major part of the discussions and the importance of agreeing data standards a key conclusion. More transparent health care systems were recommended, along with a more holistic approach and focus on quality of life for people with diabetes.

There was a very clear message about making the distinction between Type 1 and Type 2 diabetes.
