- Class sizes are restricted. Membership is allocated on a 'first come-first served' basis. Any applications received after a class has reached capacity will automatically be placed on our waiting list.
- Should a place become available, the parent/guardian will be notified by email. If the place is not taken within 7 days of notification the offer will be withdrawn and offered to the next person on the list. The application will then move to the bottom of the list.
- The named child may be photographed / recorded for appearance in videos / pictures / sound recordings. All images will be subject to our Child Protection policy.
- Any photographic, video/film or sound recording material may be used for marketing purposes by Worlds End Productions London and our associate company. You have the right to decline this consent by writing to the Artistic Director of Worlds End Productions London Ltd prior to the commencement each termly course.
- All media may also be accessible online. This will include Worlds End Productions London website YouTube, Twitter, Facebook & Instagram.
- Worlds End Productions London Ltd will take all reasonable steps to ensure that all resource and script content is suitable and appropriate for the age groups involved and for the examination level entered.
- Worlds End Productions London Drama LAMDA training classes are subject to minimum attendance. If there are insufficient numbers to run the named class, a full refund of any outstanding payments will be issued.
- Any participant may be asked to leave the class if he/she is jeopardising the safety or enjoyment of others or their educational experience. In any such case, no refund will be given for any remaining sessions of the payment period.

Cancellations and Amendments

- Classes may be cancelled by participants at any time however no refund will be given for payments made for remaining sessions

- A refund will be given for booked courses up to 7 days prior to the published starting date. Booking cancelled after this time will not be refunded.
