

## **Terms & Conditions**

All cast members must be available and able to commit to all rehearsals and performances, including the possible performance at the National Theatre.

A production fee of  $\pounds 11$  per week during the rehearsal period applies to all cast members. This covers the cost of entering the festival and all other production costs other than basic costume requirements e.g. shoes. There will be no additional fees for extra, unscheduled rehearsals and/or performances.

The production fee is payable in termly instalments of  $\pounds 110$ . Fees must be paid at the beginning of each term and no later than October 12th (Term 1) and January 4th (Term 2).

All cast members agree to be photographed / recorded for appearance in videos / pictures / sound recording during the rehearsal period and performances.

All cast members names will appear in written credits for this production.

Any photographs, film and sound materials made during the rehearsal and performance stages of the production may be used for marketing purposes for Worlds End Productions London Ltd.

All finished media will be accessible online after the course. This will include YouTube, Twitter, Facebook & Instagram as well as Worlds End Productions London's website

Worlds End Productions London Ltd accepts no responsibility for the storyline and script content but will endeavour to ensure that it is suitable and appropriate for the age groups involved.

Any cast member may be asked to leave the course if he/she is jeopardising the safety or enjoyment of others or their personal experience. In any such case, no refund will be given.

All participants, W.E.P. L. staff and teachers reserve the right to be treated with respect and consideration. W.E.P.L. does not tolerate rude, offensive or aggressive remarks or behaviour in any way.

All cast members & their parents must be aware of the health and safety rules of the rehearsal and performance venues and comply with the recommendations at all times.

Bullying, harassment, abuse or other inappropriate behaviour by cast members, relatives and/or other guests will not be accepted and will result in the immediate removal of the participant from the production and such other legal remedies as may be deemed appropriate. In any such case, no refund, partial or otherwise will be issued.

Smoking (including e-cigarettes and vaping) or the bringing or consumption of alcohol or the use or being under the influence of illegal substances is not permitted by cast members at any location used during the production. Failure to comply will result in the removal of the cast member from the production. In any such case, no refund will be issued.

## **Cancellations & Amendments**

Any changes to the rehearsal schedule or performance dates will become effective on the date of written confirmation being sent. In all cases, every effort will be made to provide as much advance notice as possible.

In the unlikely event of the production being cancelled, a full refund will be issued.

In the event of a cast member withdrawing from the production for any reason, no refund will be issued.
