The emergency byelaw regulation came into force on 18 July 2023 for an initial period of one year and officers commenced the process of supporting further investigations into the fishery alongside the development of a new byelaw regulation to strengthen the management of the activity in the longer term. The key aims of the new byelaw were to replace the current emergency regulation with flexible management framework that would support the effective management of the king scallop stock from targeted beam trawling activity alongside any associated impacts on the wider environment in the medium to longer				

	team. The Chief Officer reiterated to members although further data and information on the emerging fishery is still required, one of the key aims and objectives of the new byelaw is to ensure a mechanism is in place to manage effort and fishing activity in the Authority's district.

	The Treasurer of the Authority presented a report of the Annual Accounts for NEIFCA for the year ended 31 March 2024. The net expenditure for 2023/24 of £1,039,117 was detailed in the report. The revenue outturn underspend was £295,443 offset by a £11,498 reduction in funding transferred from reserves due to minor underspends on the supplementary budgets for the Fisheries Management Plan and Patrol Vessel Replacement Projects and was summarised in the report. The outturn position was made up of a number of compensating variances. The outturn included £150,000 additional 'grant in aid' income from the Department for Environment, Food & Rural Affairs (Defra). During the 2022/2023 financial year NEIFCA received notification that £100,000 of additional 'grant in aid' would be provided by Defra with £50,000 allocated to support Marine Protected Area and delivery towards 'good environmental status' and £50,000 to assist in supporting the delivery of the national Fisheries Management Plan (FMP) programme. Members discussed a recommendation that the underspend be committed to the vessel replacement fund including the build and commission of a new 6m open rigid inflatable boat (RIB). This new RIB would operate in tandem with the new main vessel, when delivered, during Spring 2025. Natural England representative Claire Argent questioned if it was suitable to use grant funding to support the purchase of the new RIB and if such a purchase of would meet the original grant criteria. The Treasurer and Chief Officer reassured members that the new asset would support the delivery and objectives set out by DEFRA, and due to the delay in receiving 'the grant in aid' money, the funds were replacing money already spent to meet the objectives set out by Defra initially. BUDGET MONITORING 2024/25

Report by the Treasurer

A. Purpose of Report

To advise Members of the budget position at the end of month 7 (October) in 2024/25.

B. **Recommendations**

- i. That the budget monitoring position is noted.
- ii. That the £90,000 underspend relating to Defra 'grant in aid' is transferred to the Renewals Fund as outlined in paragraph 2.3.
- iii. That the balance of any remaining underspend at outturn be transferred to the Renewals Fund.

1. Introduction

- 1.1 A detailed budget monitoring exercise is undertaken monthly by the Treasurer in consultation with the Chief Officer. This analyses individual budget lines in terms of the current expenditure and allows for projections to the end of the financial year.
- 1.2 This report provides the overall position and any areas whereby an explanation is required of any notable variance on the Authority's spending to the end of October 2024.
- 1.3 At its meeting on 8 December 2023, the Authority set a levy totalling £1,535,873 for the current financial year, including £102,900 transferred to the Renewals Fund and £10,000 transferred to the Vehicle Replacement Reserve.

2. Revenue Expenditure to 31 October 2024

2.1 Appendix A summarises the expenditure and income for the Authority for the seven months to October of the financial year and compares it with the budget. The appendix shows both subjective and objective net expenditure for the period.

- 2.2 At the end of October 2024, the Authority has net expenditure of £686,088 against an expected £826,560 underspending by £140,472. The forecast outturn underspend is £263,224. The majority of the underspend is as a consequence of the patrol vessel replacement project, planned delays in recruitment to vacant posts in the offshore team and temporarily increased bank interest receipts.
- 2.3 The underspend includes £90,000 additional Defra 'grant in aid', relating to 2023/24 financial year and received in 2024/25, made up of £50,000 allocated to support the Marine Protected Area and delivery towards 'good environmental status' and £40,000 towards Marine Sustainable Development. At the Executive meeting on 7 March 2024 (Minute 81 refers) it was agreed in principle and subsequently endorsed at the Authority meeting on 6 June 2024 (Minute 13 refers), that this 'grant in aid' funding would be used to support the build and commission of a new 6.5m 'boarding' rigid inflatable boat (RIB) a component of the new vessel build project and it is proposed that any underspend resulting from the receipt of the grant is transferred to the Renewals fund at the end of the financial year. It is uncertain whether any further tranches of grant funding will be awarded for the 2024-25 year.

2.4 The main variances in the forecast outturn are:

- Employee underspends of £115,561 mainly due to underspends from delaying recruiting to vacancies in the offshore team until the position on the patrol vessel replacement and sale of existing vessel is clearer. The forecast includes provision for payment of the flat rate £1,290 pay award (or 2.5% for the highest grades) which has now been agreed and will be paid in November 2024.
- Patrol vessel running costs overspend of £8,503 on vessel insurance. The current vessel insurance provision will be fully reviewed when the new patrol vessel is delivered.
- Supplies & services £67,691 overspend offset by a £61,300 underspend on support services. The variances are mainly due to the DEFRA funded lobster settlement project spending more on supplies & services (equipment and external services) and less on support services such as NEIFCA staff time and boat hire, than expected at the start of the project
- Grants & Contributions £81,653 underspend due to £90,000 Defra 'grant in aid' offset by in kind contributions towards the lobster settlement index project.
- Other income £74,145 overachievement of bank interest due to increases in interest rates and the level of reserves being set aside for the patrol vessel replacement. This will not be a reoccurring underspend as the majority of the reserves will be utilised to fund the new patrol vessel towards beginning of 2025/26 financial year.

LEVY 2025/26 TO 2027/28

Report by the Treasurer

A. **Purpose of Report**

To determine the levy on member local authorities for 2025/26.

To highlight issues relating to the setting of the levy for 2026/27 and 2027/28.

B. **Recommendations**

- (i) That the proposed 10.5% levy increase for 2025/26 be approved by the Authority and the Clerk be authorised to issue demands on the relevant local authorities as presented at Appendix A.
- (ii) That the Authority acknowledges the issues affecting NEIFCA and their effect upon the levy for 2026/27 and 2027/28.
- (iii) That a detailed budget for 2025/26 be brought to the Authority for approval at the Executive meeting in March 2025.

1. Background

- 1.1 NEIFCA is a statutory body, made by Order on 1 October 2010 and vested with its full powers on 1 April 2011. Article 16 of the Order sets out that 'the expenses incurred by the Authority must be defrayed by the relevant councils', therefore NEIFCA has levying powers on the relevant councils. The relevant councils and the proportion of expenses that each must bear are set out in the Order and are shown at Appendix A.
- 1.2 In accordance with standing orders, all precepts or orders for the payment of money which the Authority from time to time may issue to respective councils shall require the consent of the majority of the council representatives attending such meeting.
- 1.3 Any motion to veto the total amount of expenses incurred by the Authority, must be sent in writing to the Clerk at least three clear working days before the meeting of the Authority. The Authority must give notice in writing of that motion to each Council member.

2. Levy Considerations and Proposals

- At its meeting on 8 December 2023, the Authority agreed to increase the levy for the 2024/25 financial year by 11.5% to a total of £1,535,873 (Minute 74 refers). The increase was required to phase in the additional cost of the annual finance lease repayment for the build and commission of a new 24.5m Fisheries Patrol/Research vessel due to be operational in 2025. An indicative increase of 11.5% in 2025/26 and 2% in 2026/27 was proposed but not agreed. The levy was fixed for the period 2011/12 to 2016/17 and increased for the cost of inflationary increases in pay and other costs from 2017/18 to 2023/24.
- 2.2 The Bank of England's November monetary policy report describes an improving outlook for the UK economy as inflation stabilises around the 2% target despite continuing weak underlying economic growth. Inflation has fallen from a peak of 11% in 2022 down to 1.7% in September 2024 as prices continue to normalise following the global shocks that drove up inflation. The bank forecasts that inflation will increase to 2.7% in 2025 before falling back to the 2% target but notes that the forecast is uncertain as they cannot rule out the impact of global events, such as developments in the Middle East and that prices of some services are still rising too quickly. The bank has started to reduce interest rates is forecasting a gradual reduction from 4.75% in November 2024 to 3.7% in 2025. It is anticipated that interest rates will stabilise around 3.7% into 2027.
- 2.3 NEIFCA is continuing to experience effects of previously higher inflation as a pressure on wages, vessel and vehicle insurance and other supplies. In the Autumn Budget on 30 October 2024 the Chancellor announced that departmental resource and capital budgets beyond 2025/26 will be set by Phase 2 of the Spending Review due to conclude in late spring 2025. It is not yet known how this will impact on the specific grant local authorities receive for Inshore Fisheries and Conservation or if local authorities and in relation to potential future pressure on resources from other agencies on NEIFCA to perform additional work previously undertaken by them.
- 2.4 The National Joint Council (NJC) Local Government Pay Award for 2024/25 was agreed at £1,290 increase on pay points 2 to 43, which equates to a 5% increase for the lowest grades and a 2.5% for the higher pay points. The pay award is broadly in line with what was anticipated when the 2024/25 levy was set. It is not yet known if local authorities and IFCAs will be included in compensation to public sector employers for the increased rate of employer National Insurance Contributions from April 2025. It is forecast that the pay award will be 2% in 2025/26, 2026/27 and 2027/28. The pay award and inflationary pressures require a levy increase of 3% in 2025/26.
- 2.5 The Special Authority Meeting on 30 June 2023 approved the decision for East Riding of Yorkshire Council Cabinet to award the contract for the build and commission of a new 24.5m Fisheries Patrol/Research vessel along with a proposed finance lease agreement with ERYC. Under the terms of the finance lease agreement NEIFCA will make a substantive payment towards the costs in year one utilising funds set aside in the Renewals Fund, capital receipts from the sale of the North-East Guardian III and any further additional funding that is subject to a bid to DEFRA. It was agreed that the remaining cost will be funded by ERYC borrowing from the Public Works Loans Board and the costs will be met by the finance leasing arrangement between ERYC and NEIFCA, funded by an increase to the levy. The vessel build is progressing well and it is anticipated that the new vessel will be commissioned in spring 2025.

- 2.6 The forecast annual finance lease repayment has been revised and reduced to £201,100 from £240,590 based on the latest build costs, the forecast balance in the Renewals Fund and estimated funds from sale of the North-East Guardian III. The reduction in the annual finance lease repayment means that the requested levy increase for 2025/26 can be reduced from the 11.5% proposed at the Authority Meeting on 8 December 2023 to 10.5%.
- 2.7 In putting forward these proposals the Clerk, Treasurer and Chief Officer are mindful that authorities are facing financial pressures of their own, in particular the pressure from higher employee costs and increasing demand for public services. The current outlook remains uncertain due to reduced income from fees and charges due to the increase in cost of living, inflationary pressures and delays in the reform of local government funding. With this in mind Members are asked to consider the proposed 10.5% levy increase for 2025/26 as shown in Appendix A.

3. Reserves

- 3.1 The NEIFCA General Reserve is forecast to be £228,450 as at 1 April 2025 (Appendix B).
- 3.2 Assuming the transfer of the forecast outturn underspend at October of £263,224 is approved, the balance on the Renewals Fund is forecast to be £2,164,646 as at 1 April 2025. The reserve balance includes £240,000 for the build and commission of the new 6.5m 'boarding' rigid inflatable boat (RIB), as part of the new vessel build project, made up of £150,000 approved at the Authority Meeting on 6 June 2024 and £90,000 Defra 'grant in aid' requested to the transferred to reserves at the 2024/25 financial year end in the October budget monitoring report.
- 3.3 The Renewals Fund will be used to fund a one payment estimated to be £1,924,646 towards finance lease for the new vessel in 2025/26. The Levy proposals also include a contribution to the Renewals Fund of £102,900 for the future replacement of a new main vessel at the end of its useful life in 2045. The Renewals Fund balance is forecast to fall to £342,900 as at 31 March 2026.

NEIFCA Byelaws Update

Report by the Chief Officer

A. **Purpose of Report**

1. To inform Members on progress with the following byelaws which were made at a meeting of the Authority held on 1 December 2022:

XXVIII Shellfish Permit Byelaw 2022 XXIX Humber Estuary Fishing Byelaw 2022

2. To inform Members on progress with the following byelaw which was made at the meeting of the Authority held on 6 June 2024:

XXXIII Beam Trawling Byelaw 2024

- B. **Recommendation**
- 1. That members receive the update and note the report.
- Background
- 1.1 XXVIII Shellfish Permit Byelaw 2022
- 1.1.1 At the Authority meeting held on 1 December 2022 members supported the making of a new byelaw XXVIII Shellfish Permit Byelaw 2022 (Minute Item 32 refers).

The key aims of the new byelaw are to establish a new flexible management framework which will more effectively cover the exploitation of listed shellfish species throughout the NEIFCA district, both offshore and onshore. The new proposed byelaw will also consolidate existing byelaw regulations and introduce an effort management system for commercial potting within the district. The provisions contained within the byelaw will be applied via conditions attached to the permit which can be varied following an appropriate review process, without the need to formally remake the whole byelaw. Two permitting schemes will be established, Category 1 for licensed commercial vessels and Category 2 for recreational operators. It is proposed that during year one a maximum of 234 Category 1 permits will be offered and permit holders restricted to working a maximum of 1000 pots. A permit charge would also be levied for Category 1 permits linked to the number of pots worked. The number of Category 2 permits offered will remain unrestricted but a new £10 charge would be levied, and the number of pots permitted reduced from 10 to 5 per permit holder with daily bag limits remaining unchanged.

- 1.1.2 Since the making of the byelaw on 1 December 2022 it has been subject to further internal quality assurance checks, informal consultation with fishing groups and wider formal statutory consultation which completed on 27 October 2023.
- 1.1.3 During this process the following adjustments were made to the draft byelaw regulation:
 - Prior to the commencement of formal consultation the scope of the byelaw was
 widened to include, European green crab, mussel, common periwinkle, pullet carpet
 shell, Norway Lobster, razor clam and scallop. This was felt prudent and necessary to
 improve the active management of intertidal shore gathering by large ethnic groups
 which has become an increasing issue in some areas of the NEIFCA district.
 - Prior to formal consultation additional provisions were also added to allow for the varying of fees and charges and the implementation of management by 'pot type' alongside a further provision clarifying that, in terms of Category 1 applications, first priority would be given to those vessels who held a permit on 1 December 2022.
 - The supporting Regulatory Impact Assessments were also updated to include some additional information from the 2023 shellfish landings report and intertidal shore gathering.
- 1.1.4 Following the completion of the formal statutory consultation process on 27 October 2023 the outcome was presented to members, alongside the proposed next steps, at the Authority meeting held on 8 December 2023 (Minute 75 refers). The outcome was published on the NEIFCA website on 11 January 2024 and stakeholders notified via email.
- 1.1.5 In line with the statutory process the draft byelaw regulation and supporting documentation was sent to the Marine Management Organisation for a Quality Assurance assessment on 11 January 2024 with a recommendation that it be further considered for formal confirmation by Defra. The first phase of the MMO QA process was received back from the MMO for comment on 11 April 2024.
- 1.1.6 Following a detailed review of the recommendations from the first phase of the MMO QA assessment the draft byelaw and supporting Regulatory Impact Assessment (RIA) were revised, updated and returned to the MMO for phase 2 assessment on 12 July 2024. Whilst all of the primary intentions of the draft byelaw have been retained, key changes relate to the structuring of the byelaw, further additions to the definition and permitting sections to improve clarity for stakeholders and the removal of the longstanding deeming clause.
- 1.1.7 The MMO returned the QA phase 2 response on 12 September 2024 and following a review the RIA and draft byelaw documents were revised updated and returned to the MMO for phase 3 assessment on 24 September 2024. Officers expect the MMO QA phase 3 assessment to be returned sometime during the beginning of December 2024.
- 1.1.8 Officers anticipate that the QA process in relation to this byelaw will take a further two months to complete.

1.2 XXIX Humber Estuary Fishing Byelaw 2022

- 1.2.1 At the Authority meeting held on 1 December 2022 members supported the making of a new byelaw XXIX Humber Estuary Fishing Byelaw 2022 (Minute Item 31 refers).
- 1.2.2 Whilst retaining all existing management measures in relation to fishing activities within the boundaries of the Humber Estuary the new byelaw included a revision to the boundaries of an existing protected area to support the expansion of eel grass habitat.

- 1.2.3 Following completion of the statutory consultation process on 27 October 2023 the outcome was presented to members, alongside the proposed next steps, at the Authority meeting held on 8 December 2023 (Minute 75 refers). The outcome was published on the NEIFCA website on 11 January 2024 and stakeholders notified via email.
- 1.2.4 In line with the statutory process the draft byelaw regulation and supporting documentation was also sent to the Marine Management Organisation for a Quality Assurance assessment on 11 January 2024 with a recommendation that it be further considered for formal confirmation by Defra. The first phase of the MMO QA process was received back from the MMO for comment on 3 April 2024.
- 1.2.5 Following a detailed review of the recommendations from the first phase of the MMO QA assessment the draft byelaw and supporting Regulatory Impact Assessment (RIA) were revised, updated and returned to the MMO for phase 2 assessment on 12 July 2024. In line with the Shellfish Permit byelaw all the primary intentions of the draft Humber Estuary Fishing Byelaw have been retained and key changes relate to grammar, detail and clarity for stakeholders.
- 1.2.6 The QA phase 2 assessment was received back from the MMO on 12 September 2024 and following a review both the RIA and draft byelaw documents were revised, updated and returned to the MMO on 24 September 2024 for QA phase 3 assessment. The QA phase 3 assessment was received back from the MMO on 30 October 2024 and following a further review both the RIA and draft byelaw documents were revised, updated and returned to the MMO on 15 November 2024 for QA phase 4 assessment which should represent the final phase before final confirmation by Defra. Officers anticipate that this byelaw will now be confirmed within the next two months.

1.3 XXXIII Beam Trawling Byelaw 2024

- 1.3.1 At the Authority meeting held on 6 June 2024 members supported the making of a new byelaw XXXIII Beam Trawling Byelaw 2024 (Minute 12 refers).
- 1.3.2 The key aims of the new byelaw are to replace the current emergency regulation with flexible management framework that will support the effective management of the king scallop stock from targeted beam trawling activity alongside any associated impacts on the wider environment in the medium to longer team.
- 1.3.3 Following the making of the byelaw on 6 June 2024 formal consultation commenced on 11 July 2024 and terminated on 23 August 2024. Alongside the formal consultative process officers submitted a written request to Defra for a six-month extension to the current emergency byelaw regulation until 17 January 2025 to enable the process of making and confirming the new replacement byelaw regulation to be completed before expiry. This was consented on 17 July 2024.
- 1.3.4 During the formal consultation process officers received two written responses from hobby vessel operators objecting to the proposed requirement to hold and pay a fee for an additional permit to use a small beam trawl. Following consideration of the two objections and a review by the Executive Committee on 3 September 2024, an exemption was added to the byelaw to enable hobby operators to use a single beam trawl, not exceeding 2.5m in length, without the need to hold an additional permit.
- 1.3.5 The draft byelaw regulation and supporting RIA was submitted to the MMO for QA stage 1 review on 13 September 2024 and was received back on 30 October 2024. Following a review both the RIA and draft byelaw documents were revised, updated and returned to the MMO for QA stage 2 review on 15 November 2024. Throughout the ongoing processes officers have maintained close dialogue with both the MMO and Defra to ensure, as far as possible,

that the new byelaw will be confirmed before the emergency regulation expires on 17 January 2025.

1.4 Summary Update

1.4.1 XXVIII Shellfish Permit Byelaw 2022

Made on 1 December 2022. Currently in MMO Quality Assurance stage 3 as of 27 September 2024. Projected to be confirmed April 2025.

1.4.2 XXIX Humber Estuary Fishing Byelaw 2022

Made on 1 December 2022. Currently in MMO Quality Assurance stage 4 as of 15 November 2024. Projected to be confirmed January 2025.

1.4.3 XXXIII Beam Trawling Byelaw 2024

Made on 6 June 2024. Currently in MMO Quality Assurance stage 2 as of 15 November 2024. Projected to be confirmed January 2025.

Chief Officer's Operational Update

Report of the Chief Officer

A. Purpose of Report

To provide members with an operational report covering the period 1 June 2024 to 30 November 2024.

B. Recommendation

That Members note the report.

1. <u>Overview</u>

1.1 **NEIFCA**

New Vessel Build

Following the formal decisions taken during June 2023 to progress the build and commission of a new fisheries vessel to replace North Eastern Guardian III (NEG III) and the award of contract to Whitby based shipbuilders, Parkol Marine Ltd, on 6 October 2023, fabrication work commenced during February 2024. The first stage of the construction phase involved laying the keel through to the completion of the framing of the twin hulls in May and associated plating, including the main deck sections in July followed by the accommodation sections during September. Housing for the shafts and main engines was completed at the end of September and construction of the wheelhouse, the last section of the main superstructure, during October. Internal 'fit out' commenced during November with the installation of pipework, cable runs and internal insulating layers. Main engine installation is expected to commence at the beginning of December.

Regular updates on the build can be accessed via the Authority's website and via Parkol Marine Ltd at New Build, Yard No 64.

Currently the new vessel build remains on track for delivery during the Spring of 2025 and also on budget.

Sale of North Eastern Guardian III (NEG III)

NEG III was formally marketed for sale during May 2024 as part of a closed electronic tender process. A deadline of 31 July 2024 was set for receipt of bids which was subsequently extended to 7 August 2024. Despite a very good level of interest in the vessel it remained unsold and following consultation with the East Riding of Yorkshire Council (ERYC) procurement team, the Clerk and Treasurer, a second informal sale process was commenced on 12 August 2024. In response to that secondary process, two firm bids were received and following consultation with the Chair and Treasurer one of those bids was formally accepted on Monday 25 November 2024, subject to contract, with a provisional date of 31 January 2025 set for completion and delivery. The successful bidder is a maritime company based outside the UK in Northern Europe.

Enforcement & Compliance Work

Since June, inshore fishing activity has followed normal seasonal patterns and throughout much of the summer period the East coast enjoyed reasonably settled, warm weather which broke during September but settled again through October. Commercial catches of lobster were generally good with encouraging reports of improved edible crab catches, across parts of the district, during September. Prices, however, remained generally low through summer with lobster fetching an average of just £12.50 per Kg. Catches and landings from Redcar to Hartlepool also appear to be improving with encouraging reports coming from both Authority's officers and inshore fishermen working in that region.

Throughout the summer there were some good reports from the recreational angling sector both from the shore and at sea. On shore there were some very good catches of smooth hound, particularly along the East Yorkshire coast and offshore, cod and ling from known wreck marks, particularly off the North Yorkshire coast. Positive reporting from the sector continued through October and November particularly from shore marks along the Redcar and Cleveland and Yorkshire coast and the North and South banks of the Humber Estuary with anglers landing sizeable codling, haddock and whiting.

From a compliance perspective, through the summer period, officers continued to struggle to manage persistently high levels of unregulated and illegal intertidal shellfish gathering, particularly at Redcar and occasionally North and East Yorkshire. Almost exclusively this has involved groups of Chinese nationals. This activity continued into September and October, during the larger tides, down as far as Bridlington beach with groups targeting razor clams, mussels, cockles, winkles and other species. Offshore, compliance issues relating to the illegal scrubbing of egg bearing lobsters and non-compliance with fishing gear marking regulations have been most prevalent throughout the reporting period.

Environmental & Scientific Work

Much of the recent work of the environmental and science team has involved the assessment and response to MMO quality assurance feedback relating to the Humber Estuary and Shellfish Permit byelaws and finalising the beam trawling byelaw for quality assurance submission. Alongside that the team also completed the final report for the ELSI project, ready to be submitted to DEFRA and all associated data has been worked up to MEDIN (Marine Environmental Data and Information Network) standard. Weather permitting, staff have also been undertaking offshore lobster, crab and King Scallop stock survey work onboard local fishing vessels.

Staffing & Recruitment

I am pleased to advise that since the last Authority meeting in June, two new staff members have now joined the Environmental and Scientific team. Rachel Waite-Hudson on 5 August 2024 and Julita Ruskyte on 2 October 2024. A further recruitment process to fill the two outstanding offshore vacancies is scheduled to commence before the Christmas break in time for the delivery and commissioning of the new vessel in the new year.

1.2 National Work streams

Fisheries Management plans

On 14 December 2024 Defra published 5 Fisheries Management Plans (FMPs) including crab and lobster, sea bass, king scallop, whelk and Channel non-quota species. The development of FMPs is a key component of the 2020 Fisheries Act to inform future fisheries management policy delivery across a range of exploited stocks in the UK.

NEIFCA staff are currently directly involved in two of the current, national FMP implementation groups including crab and lobster and king scallop. One of the objectives in the crab and lobster FMP is to set up pilot scheme for the North East and South West, exploring and trialling fine scale management measures for the regions. The first focus of this pilot scheme will be to examine potential changes in the minimum landing size of lobsters. NEIFCA is a member of the supporting working group that has been setup for the lobster management trial and an initial meeting was held on 25 October 2024.

1.3 Priority Work streams for the next six months

- Monitoring construction of the new vessel through to delivery
- Finalising the sale and delivery of North Eastern Guardian III
- Submission of the finalised byelaws to DEFRA for confirmation 2025
- In terms of biological survey work, prioritising scallop dredge and beach net fisheries
- Further implementation of the new fisheries database including the capture of electronic catch and effort returns.

2.0 **NEIFCA Operational Reports**

2.1 Land-based Work streams

As weather conditions began to improve across the summer months fishing vessels worked longer, capitalising on the calm weather days.

The shore enforcement team maintained an intensive schedule of patrols and inspections on land & Sea in the NEIFCA district. Throughout the reporting period officers work hard to counteract the unregulated removal of shellfish and molluses from inter tidal zones, particularly at Redcar. Strategies ranged from active engagement, monitoring and enforcement action when appropriate. These strategies were supported by active joint working with the Gangmasters and Labour Abuse Authority to identify and individuals or groups that have potentially been forced to collect shellfish.

A small contingent of vessels in the ports of Hartlepool and Redcar targeted fish species, mainly using nets throughout summer months to catch monk fish, turbot and soles,

Nomadic scallop dredging activity remained at low levels throughout the period, outside the NEIFCA district and mainly off the coast of Scarborough to Flamborough Head. Most of these vessels landed into the ports of Scarborough, Whitby, Hartlepool. Throughout the period Officers maintained active engagement with these vessels making operators aware of the associated legislation while transiting through the NEIFCA District

Towards the end of the reporting period Officers maintained active patrolling along the Holderness coast from Fraisthorpe down to Tunstall where 5 intertidal fixed nets are permitted by NEIFCA. Sea bass have been prominent in catches during the early part of the netting season and officers have been working closely with the permitted nets men to gather biological data from the fishery.

Whilst out on patrol officers engaged frequently with recreational anglers throughout the district and also attended the Redcar & Cleveland Sea anglers angling match at the start of the reporting period. As part of that engagement officers distributed useful educational leaflets notifying anglers of any species or bag limits that maybe subject to legislation within NEIFCA District. This engagement was received very positively.

Shore Officers continue to maintain full and active engagement with the joint Intelligence gathering programme coordinated by the MMO, reporting in any information and prioritising work around key targets. Intelligence gathering and reporting has led to a number of successful operations targeting illegal fishing within NEIFCA's district. Since

the beginning of the year over 80 intelligence reports have been submitted through this programme.

Outreach and Joint Working

Enforcement Officers work alongside a number of organisations and agencies on a regular basis and it is important that links with these groups are maintained. During the reporting period NEIFCA Officers conducted joint patrols with the following organisations:

2.2 Offshore Work streams – Monthly Activity Summary

June

During June the offshore team prepared North Eastern Guardian III (NEG III) for annual slipping and marketing for sale. Staff also visited a newly commissioned catamaran vessel in Eyemouth which is of similar design to the new vessel under build in Whitby. The Authority's 6.4m RIB, Bravo 1, was active throughout June conducting vessel boardings and stock assessment surveys in the Whitby area.

July

During July NEG III and Bravo 1 undertook sea patrols throughout the NEIFCA district. During July licensed fixed netting targeting migratory seatrout, closed in the Whitby area, as per licensing conditions with only average returns reported. The Scarborough, Filey and Bridlington areas. continued to fish on until the end of August. Prices for Sea trout

averaged between £15-£20 per kilo. One vessel in the Bridlington area reported daily catches of 240kg but impacted by heavy grey seal predation. Shellfish prices in the South of the district reached £2.30kg for male brown crab, £1.60kg for female brown crab and £13kg for lobster. During the second week of July NEG III was slipped at the Parkol drydock in Whitby for two weeks annual maintenance. On 27 July 2024, officers represented NEIFCA at the Bridlington shellfish festival.

August

On 6 August 2024 Bravo I undertook some patrol work to the South of Bridlington to monitoring compliance with static fishing gear marking regulations. 34 non-compliant markers were tagged in the Bridlington-Hornsea area. The tagging system provides a warning to fishermen to mark their fishing gear accordingly prior to seizure.

On 17 August 2024 Bravo 1 provided safety vessel coverage for the Whitby Swimming Regatta, raising the profile of the IFCA within the local district. During August the Authority's 9.5m cabin RIB, Protector III, returned from the Delta shipyard, following some planned repair and upgrading work, and sea trials were completed on the 20 August 2024. Whist undertaking offshore patrol work large herring marks were observed on the vessel's sonar equipment, this was later confirmed and observed when undertaking boardings of potting vessels, who reported hauling pots containing considerable quantities of live herrings.

September

During September the offshore team supported the shore operations team carrying out joint patrol work within the district and also the Deputy Chief Officer who is currently leading the management and oversight of the new vessel build.

October

During October some maintenance issues were resolved onboard NEG III including a bow thruster fault and the replacement of some relay switches.

The onboard Forward Looking Infra Red (FLIR) camera which had been removed from NEG III for servicing was returned. This camera, valued at £70K will be mounted on the new build vessel.

During the month an offence was detected, angling for Bass in the no-take zone at Sewerby. The vessels Skipper was escorted out of the zone and was given a verbal warning. A single nomadic scalloper was also intercepted East of Flamborough Head dredging just beyond the Authority's district the vessel was displaying its AIS and no offence was observed being committed.

Sei Whales were also observed within the district, mainly in the 3-4 nm stream sometimes numbering as many as six in one group

November

During November lobster prices reached £17kg and the brown crab price, £1.80 for females and £2.30 for males. Protector III took over the bulk of the offshore patrol effort. Two out of the three permitted scallopers were observed fishing in the seasonal scallop boxes and monitored on a number of patrols. No nomadic scallopers were observed. One

member of the offshore team assisted the shore team and the Environment Agency with illegal gill netting close to Whitby, resulting in an offence being recorded.

2.3 Environmental/Science Work streams

2.3.1 Consents and Licensing

The NEIFCA district is of great interest to many commercial parties and operators. The list of activities includes, but is not limited to, offshore renewables (wind and tidal), gas cavern development, harbour works, maintenance and capital dredge activities, pipeline and cable corridors/landfall and mine discharge. As a relevant authority, NEIFCA is consulted on all developments within and abounding the district, including the issuing of marine consents or licenses relating to any form of discharge or abstraction.

Applications relating to marine developments can be numerous and each one is considered both independently and cumulatively with any other neighbouring activities. Authority Officers also often play an active role in working groups established for the monitoring and surveillance of developments. 2.3.2 ELSI project update

The project has come to an end and a final report has been drafted and to be submitted by the 15th December 2024. Between May and October 2024, plankton tows were undertaken across the district, from Redcar to Withernsea. Local industry vessels were hired and in collaboration with the University of Hull a total of 78 plankton tows were completed. The University of Hull has completed the analysis of all the plankton and settlement cage samples and all the data are going to be submitted to MEDIN (Marine Environmental Data and Information Network). To date, only 1 Early Benthic Phase lobsters has been found off Flamborough Head, highlighting the challenges in finding these juvenile lobsters. The results of the plankton surveys demonstrate a clear difference in density between North and South of Scarborough with higher density of planktonic lobster larvae in the southern part of the district. The highest number of planktonic lobster larvae throughout the summer were recorded in July. NEIFCA will continue the work, focusing on improvements to the settlement cages and locations and planktonic larval distribution. The overall aim of this work is to improve stock assessment and the results of this study are an important steppingstone for further research and trials.

2.3.3 Survey Programme Update

Between May 2024 and October 2024, with the support of the, biometric data for 174 Shore Operations Team 7 lobsters and 485 edible crabs were collected across 4 observer trips and 14 boardings on fishing vessels.

Between June 2024 and November 2024, the Environmental and Shore Operations Team completed 31 quayside sampling trips in three major ports of the district (Bridlington, Scarborough and Whitby). Biometric data for 2678 lobster and 1767 edible crabs were collected across these three ports.

The annual Eelgrass survey was completed in collaboration with the Yorkshire Wildlife Trust in July 2024. The outcome of this survey was used to inform the Scientific Advisory Group and current Humber Estuary Byelaw.

In September 2024, a local trawler was hired for the annual Scallop dredging surveys in and around the North and South Box and a total of 36 tows were completed. The outcome and state of the stocks will be included in an annual stock monitoring report and presented to the Scientific Advisory Group in March 2025.

3.0 National Meetings Update

3.1 National IFCA Chief Officers Group

At present the Chief Officer's group meets monthly and is made up of the most senior IFC Officers in the U.K. Group membership also includes Officers from Fisheries Departments located in the Isle of Man, Jersey and Guernsey.

The group provides an extremely valuable mechanism for the discussion and exchange of information relating to operational and legislative matters affecting 'day to day' activities within IFCA's and NEIFCA currently provides the Secretariat to the group.

Since the last meeting of the Authority NEIFCA was represented at seven meetings held on 26 June, 10 July, 16 August, 18 September, 16 October and the 12 and 13 November 2024.

3.2 National Association of IFCAs Forum & Directors Meetings

The national Association of IFCA's was formally established on 17 March 2011 following resolution and adoption of draft Articles by majority vote. NEIFCA's interests within the group are represented by the Chair, Vice Chair and Chief Officer.

The national Association is structured as a Company by Limited Guarantee with listed Directors and members and its Articles reflect that structure and governance. This enables the Association to employ its own staff (currently Chief Executive, a full-time support Officer and a fixed term project officer) and conduct its business within a properly structured legal framework. One Director is appointed by each of the member IFCA's currently the Chief Officer and the wider membership of the Association or forum comprises of three representatives from each member IFCA, currently the Chairman and Chief Officer. The board of Directors meet after the forum to consider business and actions resulting from it. The Chief Executive is a Director of the Association as are the elected Chairman and Vice Chairman of the wider members Forum.

Since the last meeting of the Authority NEIFCA was represented at one forum meeting and one Directors meeting held on 3 September and 16 October respectively.

Science Advisory Group Update

Report by the Chair of SAG & the Environmental & Scientific Manager

A. **Purpose of Report**

To update members on the most recent proceedings of the Science Advisory Group (SAG) following meetings held on 17 September 2024.

B. **Recommendation**

That members note the report and consider the Group's recommendations.

1. **Background**

1.1 Since the last Authority meeting held on 6 June 2024, one meeting of the SAG was held on 17 September 2024 and is summarised below.

At the meeting members considered the following items:

- Elect chair
- European Lobster Settlement Index (ELSI) update
- Emergency Byelaw 2023
- Eelgrass survey 2023
- Permit & Catch Return system

Election of chair

All members agreed to elect Claire Argent, Natural England Representative, as chair for another year.

ELSI update

Environmental & Scientific Manager Ralf Bublitz presented a report to update members on the ELSI Project with the results. The group advised to improve the settlement cages using substrates to better simulate the seabed features in the settlement cages for example waterpipe and the creation of flat ledges so that larvae could settle below them. Funding from DEFRA's Fishing Industry Science Partnership (FISP) programme has now ended and the project is scheduled for completion by the end of October. Environmental & Scientific Manager Ralf Bublitz explained how the research could be taken further by using

a camera to record how the larvae disperse and interact around the cage when released, funding for this is under review.

Scallop Beam Trawling Byelaw 2024

Environmental & Scientific Manager Ralf Bublitz updated the group of beam trawling activity in 2024 and compared it to 2023 using the results from the scientific dispensation scheme implemented through the Emergency Beam Trawl Byelaw in July 2023. Since the beginning of the 2023/24 scallop dredging season 77.7 tonnes have been landed by beam trawling compared to 48.7 tonnes that have been landed by dredging. Environmental & Scientific Manager Ralf Bublitz explained that, on average, the CPUE is higher for beam trawling than dredging, this is attributed to the location of fishing grounds available. The majority of dredging takes place in the North Box which has led to a decrease in stocks. Due to the timing of the meeting there was not sufficient time to create a more accurate assessment of the stock, which would aid in the recommendation of management. It was discussed that a precautionary approach should be taken which would result in the closure of the North Box until further analysis of the data is available.

Eelgrass survey 2024

Environmental & Scientific Officer Rachel Waite-Hudson presented a report to members on the outcome of the Yorkshire Wildlife Trust's annual Spurn eelgrass survey. The number of eelgrass cells has increased from 2023 with the majority of growth in the north of the eelgrass bed. There was a loss of eelgrass that followed the inside boundary of the protected area in the centre of the eelgrass bed.

Rebecca Lynam partook in the data collection for the survey and expressed that human error likely caused the appearance of a large loss of eelgrass in the centre of the eelgrass bed, additionally diversions were made due to terns at the survey site. Clare Fitzimmons highlighted the improvement of satellite imagery and suggested this be considered in the future. As the Humber Estuary Byelaw approaches sign off, the extension of the prohibition box will aid in the stability of eelgrass and hopefully promote new areas of eelgrass growth.

Any other business

Assistant Operational Support Officer, Emma Jones presented the new permit and catch return system and its functionality. Members were shown how the new system will work for stakeholders to submit their own catch returns and the features that they will be able to access to assess their own catch rates. MMO representative Andrew Earle raised a query with regards to stakeholders being able to access their own data, as issues had arisen with this through the MMO app. Assistant operational officer Emma Jones Emma agreed to contact the GDPR representative at ERYC to advise on this.

This report provides a summary account and review of North Eastern Inshore Fisheries and Conservation Authority's (NEIFCA) main outputs and achievements between 1 April 2023 and 31 March 2024.

Whilst the year presented some challenges for NEIFCA staff, there were also some notable, landmark achievements. Following almost a decade of preliminary work, on 6 October 2023, a contract was signed with Parkol Marine Ltd, a local ship builder, based in Whitby, North Yorkshire, to build and commission a new main offshore vessel to replace North Eastern Guardian III. This new vessel will be unique in its class and the next generation of a long line of vessels, dating back to 1905, designed and built to further the protection, enhancement and development of inshore fisheries along the North East coast of England.

Significant progress was also made in the development and progression of a new shellfish management byelaw which will enable NEIFCA to deliver a much more effective and proactive system management across commercial and recreational fisheries targeting crab, lobster and other shellfish species. Following a comprehensive period of formal consultation the byelaw was submitted to the Marine Management Organisation (MMO) for stage 1 Quality Assurance on 11 January 2024.

During the reporting year NEIFCA operational support staff played a key role in furthering the development of the Authority's fisheries permitting database to a point where the majority of permit applications and re-applications are processed electronically alongside the submission of monthly commercial catch and effort return. This work has significantly improved service delivery.

Finally, 2023/2024 also heralded some notable changes in terms of the internal leadership of NEIFCA. During December 2023 Caroline Lacey stepped down from her role as the Clerk and Darren Stevens, Director of Corporate Resources at East Riding of Yorkshire Council (ERYC), was appointed as her successor. The Clerk provides independent governance and procedural oversight within NEIFCA. Throughout her time as Clerk, Caroline played a central role in progressing the build of the new main offshore vessel and also overseeing the implementation of the 2020 NEIFCA organisational review.

NATIONAL VISION

To lead, champion and manage a sustainable marine environment and inshore fisheries by successfully securing the right balance between social, environmental and economic benefits to ensure healthy seas, sustainable fisheries and a viable industry.

EXECUTIVE SUMMARY

NEIFCA was formally established on 1 April 2011 under provision contained within the 2009 Marine and Coastal Access Act. It replaced North Eastern Sea Fisheries Committee (NESFC), assuming new duties and responsibilities for managing the sustainable exploitation of sea fisheries resources within its district.

This Annual Report covers the period 1 April 2023 to 31 March 2024. It provides a comprehensive review of its main outputs and achievements across key work areas including: Organisational; Legislative Enforcement; Environmental and Scientific Research; Staff training and development; Communications; Partnership working and additional work supporting the delivery of national work streams. The report also provides a summary of NEIFCA's performance and progress against both longstanding national and local working objectives.

EXECUTIVE SUMMARY ACHIEVEMENTS

Main achievements and outputs during 2023/2024 included the following:

- Agreement achieved with members on an uplifted, sound and stable operational budget of £1,377,464.
- On 17 July 2023 NEIFCA utilised its emergency byelaw making powers under Section 157 of the Marine and Coastal Access Act 2009 to ensure the effective and proactive management of an emergent beam trawl fishery targeting king scallops within its district.
- On 17 July 2023 NEIFCA published its second appraisal of landing trends at key ports surrounding the Tees and North Yorkshire following the shellfish mortality events which occurred in the region during October 2021.
- During October 2023 NEIFCA commenced a pilot trial supporting the electronic submission of fishing catch and effort returns as part of the ongoing development of the new fisheries permitting database. This work paralleled the implementation of a new electronic application process for recreational shellfish permits.
- On 6 October 2023 a contract was signed with Parkol Marine Ltd, based in Whitby North Yorkshire, for the build and commission of a new main offshore fisheries vessel. The new vessel is expected to be delivered sometime during the spring of 2025.

- On the 11 January 2024 the Humber Estuary Fishing Byelaw and the new shellfish permit byelaw were submitted for first stage MMO Quality assurance representing the first step towards formal confirmation. The Humber Estuary Fishing Byelaw will enhance protection for sensitive eelgrass beds occurring on the Humber Estuary and the shellfish management byelaw will enable more proactive and effective management of exploited shellfish stocks both offshore and onshore.
- Active engagement and involvement in the national development and implementation of Fisheries Management Plans (FMPS) for key stocks including, King Scallops, Crabs and Lobster, sea bass and whelk through the associated working groups, consultation and publication on 14 December 2023.
- Successful completion of the final years survey work relating to the European Lobster Settlement Index (ELSI) project.

EXECUTIVE SUMMARYACHIEVEMENTS CONTINUED

Partnership Working

- NEIFCA retains a strong commitment to active partnership working and continues to build on that through active collaboration with the Marine Management Organisation (MMO), the Department for the Environment Food and Rural Affairs (DEFRA), the Seafish Industry Authority and the Centre for the Environment, Fisheries and Aquaculture Science (CEFAS). During 2023/2024 much of that work involved supporting the national development and implementation of Fisheries Management Plans (FMPS) a new statutory requirement of the 2020 Fisheries Act. With additional grant aid support, provided by Defra, NEIFCA was able to enhance resourcing within its Environmental and Scientific team and strengthen its active involvement in the development of six 'front runner' FMP's including King Scallops, Crab and Lobster, sea bass, whelk and Southern North Sea and English Channel mixed flatfish. This work included attending national and local workshops, imputing directly into the development of the draft plans and responding to the formal consultation through to publication on 14 December 2023. Going forward from 2023/2024, NEIFCA's involvement in both the implementation of established FMPS and the development of new plans for other species will become an established component of its annual work programme.
- From an enforcement and compliance perspective NEIFCA maintained an active and collaborative working relationship with MMO colleagues which included attendance and participation in monthly joint Tasking and Coordination Group (TCG) meetings. These meetings enable the review of shared intelligence and the associated tasking of joint actions to tackle issues as they emerge and develop locally. During 2024 this work was further enhanced through the commissioning of a bespoke joint intelligence database known as 'CLUE'. As a result of this collaborative approach several joint enforcement operations were undertaken to target illegal activities. During 2023/2024 NEIFCA officers issued 24 verbal warnings and 4 written warnings for a range of offences and a further 7 cases were formally prosecuted in local Magistrates Courts for non-compliance with local byelaw and national fisheries legislation.
- During 2023/2024 further joint working was undertaken in conjunction with the Gangmasters and Labour Abuse Authority (GLAA), the Borders Agency and local policing and public protection teams in response to the illegal gathering of certain intertidal shellfish species within the Authority's district. Officers also worked actively with the Environment Agency (EA), policing intertidal netting activity along the coast.



INTRODUCTION

Introduction

This 2023/2024 Annual Report provides a summary of NEIFCA's main outputs and achievements across Central policy, encompassing strategic development and legislative review; Legislative enforcement; Environmental and scientific research, encompassing fisheries stock assessment, marine survey and monitoring, data management, review of marine consents and licensing applications and marine habitat protection; Staff training and development: Communications and partnership working. The report complements NEIFCA's 2023/2024 Annual Plan and also provides a summary of progress against longstanding national IFCA success criteria and high-level objectives.

Background

NEIFCA was established in October 2010 under provisions contained within the Marine and Coastal Access Act 2009. On 1 April 2011, it assumed full statutory responsibility for managing the exploitation of sea fisheries resources within its jurisdiction. Since its inception it has drawn professional service provision including legal, financial and human resource support from its lead Local Authority member, East Riding of Yorkshire Council (ERYC). NEIFCA membership totals 30 and comprises of 13 elected councillors, representing 11 coastal local authorities together with 14 members appointed by the Marine Management Organisation and singular members representing Natural England, the Environment Agency and the Marine Management Organisation.

Financial Overview

NEIFCA's total annual budget for the reporting period 2023/2024 was agreed by members during March at £1,377,464. The budget was allocated across four main areas:

Corporate

Expenditure relating to corporate governance.

Headquarter

The cost of management and administrative support.

Operations

Direct expenditure incurred in the performance of the authority's objectives comprising of offshore, land-based and environmental activities.

Grant aided projects

Projects which are specific or time bound and wholly funded by external sources.

COMPREHENSIVE INCOME AND EXPENDITURE STATEMENT

Income versus expenditure is summarised in the following tables covering the 2023/2024 financial year. The final budget outturn shows an underspend of £283,944. This outturn position is made up of a number of compensating variances including: Staffing vacancies, some of which were planned, and additional income which had not be factored into original budget projections including, external grant aid payments and more favourable banking interest rates. Due to extensive periods of vessel layups through 2023/2024 the offshore fuel budget was also under utilised. The savings generated through 2023/2024 were transferred to support the financing of the new vessel build.

ORGANISATIONAL REVIEW 2023/2024

Main Achievements

- During December 2022 members endorsed and set an operational budget of £1,377,464 for the 2023/2024 year, providing a stable and uplifted funding base
- On 17 July 2023 NEIFCA utilised its emergency byelaw making powers under Section 157 of the Marine and Coastal Access Act 2009 to ensure the effective and proactive management of an unforeseen, emergent beam trawl fishery, targeting king scallops within its district which couldn't be managed under existing fisheries byelaw provisions.
- On 17 July 2023 NEIFCA published its second appraisal of landing trends at key ports surrounding the Tees and North Yorkshire following the shellfish mortality events which occurred in the region during October 2021. This report included a more detailed assessment of available catch and landing data, covering a longer time frame, and highlighted significant reductions of crab and lobster catches, particularly at Redcar and Hartlepool surrounding the Tees Estuary.
- During October 2023 NEIFCA commenced a pilot trial supporting the electronic submission of fishing catch and effort returns as part of the ongoing development of the new fisheries permitting database. This work paralleled the implementation of a new electronic application process for recreational shellfish permits.
- On 6 October 2023 a contract was signed with Parkol Marine Ltd, based in Whitby North Yorkshire, for the build and commission of a new main offshore fisheries vessel. By the end of the reporting period on 31 March 2024 much of the after-hull structure had been completed. The new vessel is expected to be delivered sometime during the spring of 2025 and remains on time and on budget.

- On the 11 January 2024 the Humber Estuary Fishing Byelaw and the new shellfish permit byelaw were submitted for first stage MMO Quality assurance representing the first step towards formal confirmation. The Humber Estuary Fishing Byelaw will enhance protection for sensitive eelgrass beds occurring on the Humber Estuary and the shellfish management byelaw will enable more proactive and effective management of exploited shellfish stocks both offshore and onshore.
- Throughout the reporting period NEIFCA staff have been actively engaged and involved in the national development and implementation of Fisheries Management Plans (FMPS) for key stocks including, King Scallops, Crabs and Lobster, sea bass and whelk through attendance on associated working groups and submitting responses to formal consultative processes which culminated in the publication of 6 'front-runner' FMPs on 14 December 2023. Engagement in this workstream has been supported by additional grant aid provided by Defra and included the appointment of an additional officer on a one year fixed term contract.
- With support from external partners, including Hull marine laboratory based in the University of Hull and some local fishing vessel operators the final planned year of the European Lobster Settlement Index (ELSI) project was successfully completed and a final report on the project will be released sometime during the Spring of 2025.

CENTRAL POLICY 2023/2024

Central Policy and Strategic Development

Central policy and strategic development is supported by two key internal sub-groups, the Executive Committee and the Science Advisory Group. The Science Advisory Group comprises of MMO appointees and representatives from Natural England, the Environment Agency and the MMO and is responsible for overseeing regulatory review, development and implementation, scientific and survey work, projects and licensing applications and consents. The Executive Committee comprises of elected and appointed MMO members and provides a smaller more focused decision making group to undertake any work delegated by the full authority, including ratifying emergency byelaw provisions and considering appeals against process. These groups work in tandem with recommendations passing through the Executive Committee for final endorsement by the full authority.

Risk Management

The effective management of risk remains a key priority for officers and members of the authority. A formal strategy supporting the identification and management of risk was first agreed and adopted by members of the shadow authority on 25 January 2011. The strategy and its provisions are reviewed on an annual basis to ensure that it remains 'fit-for-purpose'.

Alongside the strategy, the identification and management of risk is supported through a number of risk registers covering both strategic and operational risk, including a risk-based enforcement matrix. All risk registers are subject to six-monthly review with updates reported to authority members and posted on the authority's website. During the reporting year, these reviews and updates were completed during March and September 2023.

Emergency IFCA Byelaws

Section 157 of the Marine and Coastal Access Act 2009 provides a mechanism for IFCA's to introduce emergency byelaw regulations to deal with unforeseen issues requiring urgent action. Emergency byelaws are time limited to a maximum period of eighteen months. Since its inception in 2011, NEIFCA has effectively utilised its emergency byelaw making powers on six separate occasions, including this current, 2023/2024, reporting year. On 17 July 2023 NEIFCA confirmed an emergency byelaw to enable the effective management of an unforeseen emergent beam trawl fishery targeting King Scallop within its district. This has enabled NEIFCA to control the numbers of vessels accessing the fishery, set fishing conditions and in combination with existing byelaw regulations, gather for information on the fishery to inform future management. This emergency byelaw is scheduled to expire on 17 January 2025.

LEGISLATIVE ENFORCEMENT

Legislative enforcement forms a key element of the authority's drive to achieve the sustainable management of sea fisheries resources within its district. Enforcement is undertaken by fourteen warranted Inshore Fisheries and Conservation Officers (IFCOs) who are responsible for monitoring and inspecting fisheries activities, both offshore and along the coast. Enforcement work is supported by a dedicated 26 metre patrol vessel, North Eastern Guardian III (NEG III), which carries a 6.4 metre rigid inflatable boat (RIB) that is utilised to board and inspect fishing vessels at sea and a 9.5 metre cabin RIB to support its offshore operations. NEG III will be replaced during the 2025/2026 reporting year with a new 'state of the art' 25 metre catamaran with significantly enhanced enforcement and offshore survey capabilities.

During the 2023/2024 reporting period offshore enforcement and compliance work was impacted by unforeseen mechanical issues onboard both NEG III and Protector III, NEIFCA's 9.5m cabin RIB. These issues were rectified by the end of the reporting year but critical and often complex repair work left both vessels out of service for extended periods.

New Vessel Build

On 6 October 2023 a contract was signed with Parkol Marine Ltd, based in Whitby North Yorkshire, for the build and commission of a new main offshore fisheries vessel to replace NEG III. The new vessel, a 25m aluminium catamaran, has been designed to meet NEIFCA's developing operational needs and will significantly enhance its offshore capabilities particularly in relation to the assessment of marine habitats, fish stocks and the effective delivery of its enforcement and compliance work. By the end of the reporting period, on 31 March 2024, much of the after-hull structure had been completed and the project remains on schedule for delivery sometime during spring 2025. The new vessel build is funded through a combination of planned savings, capital raised through the sale of NEGIII and funding accessed through the Defra IFCA Capital Delivery programme.

ENVIRONMENTAL AND SCIENTIFIC RESEARCH

Marine environmental and scientific research functions continue to develop and expand in line with the developing role and remit of the authority. The environmental and science team undertake fisheries stock assessment work, collate and analyse seabed habitat and water column data, review marine licensing applications and consents, support marine habitat conservation and management through engagement with European Marine Site (EMS) management schemes and Marine Conservation Zone (MCZ) programmes and oversee the internal management of data. This work is guided by an annual research and evidence plan and a five-year strategic plan.

Fisheries Stock Assessment work

The majority of species exploited within the NEIFCA district are a component of wider stock units which extend beyond the six-mile limit and also into neighbouring IFCA districts. During 2011/2012 officers developed some multiple fishery indicator frameworks, a combination of specific reference points and proxies for measuring progress towards achieving sustainable fish stocks. Alongside and at the request of NEIFCA members, officers have incorporated a broader overview, detailing information on gear types, additional species alongside economic and socio-economic factors. This analytical work continues to develop and evolve and is underpinned by a comprehensive stock assessment programme which includes quayside sampling at four main ports including Hartlepool, Whitby, Scarborough and Bridlington and an offshore monitoring programme covering each of the five main ICES areas located within and surrounding the authority's district.

Marine Licensing and Consents

During the reporting period, authority officers reviewed 18 licensing and consent applications covering a wide range of projects from maintenance and capital dredging to discharging at sea and large infrastructure applications, including developments within major ports in the Tees and Humber estuaries, offshore renewables, pipelines and cabling.

Shellfish Mortality - Tees & North Yorkshire

Since the shellfish mortality event in October 2021, NEIFCA Officers have been supporting the key agencies (DEFRA, EA, CEFAS & MMO) with sampling and logistics, dissemination of any further wash-up events and reports, liaising between agencies and engaging industry through working groups. Monitoring trends in MMO and NEIFCA landings data also continued and a second landings monitoring report was published in July 2023. A wash-up log was initiated at the start of the shellfish mortality event in October 2021 capturing records of any wash up events and associated reports from the industry, public and social media. This log was also used to support the assessment of the shellfish mortality event by an Independent, expert panel appointed by government in December 2022. The panel reviewed all available evidence and published its findings in January 2023 concluding that it was highly unlikely that capital dredging works surrounding the Tees estuary could have caused the mass mortality. Officers continue to monitor the relevant sites for any potential wash up events and are prepared to respond quickly and liaise efficiently with key agencies if such an event ever re-occurs. NEIFCA's annual stock monitoring programme will also pick up trends in fisheries within the affected areas in the medium to longer term. At present those trends are improving as recovery continues.



MARINE PROTECTED AREAS

European Marine Sites (EMS)

The NEIFCA district contains five European Marine Sites (EMSs); Northumbria Coast, Teesmouth and Cleveland Coast, Flamborough Head, Humber Estuary and the Greater Wash. Flamborough Head and the Humber Estuary are each supported by a management group comprising statutory authorities and other relevant bodies and NEIFCA plays an active role in each. NEIFCA workstreams within the EMSs focus on four main areas; active participation in the EMS management schemes and associated projects; the provision of guidance to developers and input into the licensing conditions of development consent orders within and adjacent to EMSs; stock assessments of commercially important finfish and crustacea; and the appropriate assessment and management of fisheries within EMS boundaries through both voluntary and regulatory measures. Significant progress was made during 2019/2020 in reducing risk to designated Marine Protected Area (MPA) features associated with fishing activity. A seasonal netting prohibition in the waters surrounding Flamborough Head and Filey Brigg came into force to protect the largest mainland UK breeding seabird colony; home to 412,000 seabirds. In addition, a trawling permit management system was introduced for the Humber Estuary. Control of trawl effort will help to protect the valuable habitats and species within the estuary, which also acts as vital spawning and nursery grounds for a range of fish species. Regulations to improve fishery data collection have also been approved. Such regulations remain under continuous review to ensure that they maintain appropriate levels of feature protection across all the MPAs located within the NEIFCA district. During the reporting period two new byelaw regulations were submitted to the MMO for stage 1 quality assurance.

The provisions contained within those regulations included an extension to an MPA within the Humber Estuary to improve protections for seagrass habitat and a new management framework to restrict the number of pots worked by each vessel operating within the NEIFCA district.

Marine Conservation

The NEIFCA district contains two MCZ sites; Runswick Bay and Holderness Inshore. Full assessments have been completed on both sites and appropriate management measures supporting their protection are already in place. Work to establish a new Management Group to encompass both MCZs is supported through the Yorkshire Marine Nature Partnership.

Data Management

All raw data gathered from the NEIFCA district is stored electronically in a format enabling ease of manipulation, import into other programmes and statistical analysis. Spatial data is stored in shape file format for presentation and analysis in the GIS platforms. This is a developing workstream that aims to generate key data layers that present information related to the NEIFCA district, such as management regimes, fishing effort, habitat types and commercial species ranges.

EXTERNALLY FUNDED PROJECTS AND INITIATIVES

European Lobster Larval Settlement Index Project

Funded through the Defra UK Seafood Scheme this is a two-year partnership project with the Holderness Fishing Industry Group which started in February 2022. The project aims to better understand the distribution and abundance of lobster larvae and newly settled post-larval lobster (Early Benthic Phase Lobster) within the NEIFCA district. This information will be key for the development of a more predictive stock assessment in the future. For this project, 40 settlement cages were deployed across the district between May and September in 2022 and 2023. At the end of each survey season all cages were recovered and the first Early Benthic Phase (EBP) lobster was found in one of the cages off Flamborough Head. This is the first time an EBP lobster has been captured in the UK using this method. Additional valuable data was collected on the biodiversity of the benthos and seasonal abundance and stages of planktonic lobster larvae. More data will be collected throughout the 2024 season. A final project report will be published sometime during the 2024/2025 reporting year.

STAFF TRAINING AND DEVELOPMENT

A new staffing appraisal system was implemented during November 2021 and has been further developed through 2023/2024. This new system is linked to pay progression and performance and has strengthened the identification of individual training and development needs across all the operational teams. Alongside it, progress against staff training and development needs are now monitored centrally and reviewed on a six-monthly basis. Further ongoing work is also supporting leadership and management development across the Authority's senior management team.



COMMUNICATIONS, PUBLIC ENGAGEMENT AND PARTNERSHIP WORKING

NEIFCA Website

The authority's website and social media, such as Facebook, remains at the forefront of its drive to improve overall communications, accessibility to information and associated services. A new Authority website 'went live' during March 2022. It carries a much clearer, simpler format which is more straightforward to navigate. Authority staff can now edit and update the content directly which means that information can be updated on a much more regular basis. Stakeholders can access a range of services from the website including applications for fishing permits and provision of feedback on a wide range of topical issues.

Tyne to Tees, Shores and Seas - SeaScapes Partnership

The SeaScapes project is a partnership of local, regional and national organisations working in the coastal, marine and heritage sectors that have come together to better protect and celebrate the unique coastline between the rivers Tyne and Tees. The first National Lottery Heritage Fund supported Marine Landscape Partnership will deliver around 23 projects over the next four years worth £5 million to the communities of South Tyneside, Sunderland, Durham and Hartlepool.

Yorkshire Marine Nature Partnership

Delivery of a well managed network of Marine Protected Areas (MPAs) is a key work area for NEIFCA. With the growing number of MPAs, effective site management requires new ways of working and a collaborative approach. As a member of the Flamborough Head European Marine Site Management Group, National Lottery Heritage Funding was obtained to establish the Yorkshire Marine Nature Partnership. The emerging partnership is focussed on supporting, understanding, managing and caring for Yorkshire's seas, coastline and hinterland, working with cross-sector partners to achieve shared aims and promote holistic action in the marine and coastal environment.

Feedback System

During March 2022 NEIFCA agreed a new service level agreement with East Riding of Yorkshire Council for the provision of enhanced support covering both feedback and information governance. This support was utilised during 2023/2024 to assess and respond to a number of Freedom of Information (FOI) requests and one formal complaint.

Partnership Working

NEIFCA works extensively, collaboratively and proactively with a wide range of partner agencies and organisations, most notably, the MMO, Environment Agency (EA), Defra, the Seafish Industry Authority and the Yorkshire Wildlife Trust. During 2023/2024 much of that associated work involved supporting the national development and implementation of Fisheries Management Plans (FMPS) a new statutory requirement of the 2020 Fisheries Act. With additional grant aid support, provided by Defra, NEIFCA was able to enhance resourcing within its Environmental and Scientific team and strengthen its active involvement in the development of six 'front runner' FMP's including King Scallops, Crab and Lobster, sea bass, whelk and Southern North Sea and English Channel mixed flatfish. This included attending national and local workshops, imputing directly into the development of the draft plans and responding to the associated formal consultation through to publication on 14 December 2023. Going forward from 2023/2024, NEIFCA's involvement in both the implementation of established FMPS and the development of new plans for other species will become an established component of its annual work programme, delivered through active, collaborative partnership working with key agencies, organisations and both commercial and recreational stakeholders.

Further collaborative partnership working was fostered at national level through the IFCA Chief Officers Group (COG) and the Defra Marine and Fisheries Chief Officers Group (MAFCO).

From an enforcement and compliance perspective NEIFCA maintained an active and collaborative working relationship with MMO colleagues which included attendance and participation in monthly joint Tasking and Coordination Group (TCG) meetings, the national joint Strategic Operational Group (SOG) and the National Inshore Marine Enforcement Group (NIMEG). The monthly TCG meetings enable the review of shared intelligence and the associated tasking of joint actions to tackle issues as they emerge and develop locally. During 2024 this work was further enhanced through the commissioning of a bespoke joint intelligence database known as 'CLUE'. Since the commissioning of the 'CLUE' system NEIFCA has uploaded over 60 individual fisheries intelligence records covering a wide range of issues. As a result of this collaborative approach several joint enforcement operations were undertaken to target illegal fisheries activities during 2023/2024.

Throughout the reporting period extensive joint working was undertaken by NEIFCA's shore operations team in conjunction with the Gangmasters and Labour Abuse Authority (GLAA), the Borders Agency and local policing and public protection teams in response to the illegal gathering of certain intertidal shellfish species throughout the Authority's district. Officers also worked actively with the Environment Agency (EA), policing intertidal netting activity along the coast.

National IFCA Association

A national association was established on 24 March 2011 to represent and support the work of IFCAs. NEIFCA continues to play an active role in this association through the Chairman and Chief Officer. Throughout 2023/2024 the national Association of IFCAs (AIFCA) played a strong supporting role across the ten IFCAS delivering cohesion and collaboration which included supporting IFCA engagement across a number of national projects including the Coastal Health and Livelihoods project (CHLE), a CEFAS led project which is focused on improving the planning, programming and response to unforeseen events impacting on the health of the marine environment and associated livelihoods such as the Tees and North Yorkshire shellfish mortality event.





IFCAs are recognised and heard, whilst working in partnership and engaging with stakeholders; IFCAs implement a fair, effective and proportionate enforcement regime;

IFCAs use evidence based and appropriate measures to manage the sustainable exploitation of sea fisheries resources and deliver marine environmental protection within their districts;

IFCAs have appropriate governance in place and staff are trained and professional;

IFCAs make the best use of evidence to deliver their objectives;

NATIONAL IFCA SUCCESS CRITERIA

NEIFCA work streams and organisational priorities are geared towards the positive achievement of the national vision: outlined on page 4.

To support the positive delivery of the above national vision, IFCAs have agreed a set of national success criteria matched with corresponding working-level objectives. The vision, success criteria and national working objectives are designed to assist in the creation of a shared understanding of the aims and objectives of IFCAs nationally and focus positive service delivery towards achievement of the national vision. These national IFCA performance criteria also link directly to the UK Marine Policy Statement.

Focus and Priorities for the Year - Annual Plan 2023/2024

Each year authority members agree and set their objectives and priorities for the year ahead which are outlined within the summary work programme contained within the authority's 2023/2024 annual plan. The 2023/2024 plan was adopted by members on 14 March 2023.

NATIONAL IFCA WORKING LEVEL OBJECTIVES

The following tables provide a summary of the authority's progress towards achieving the Success Criteria and supporting Working Level Objectives (WLO) during the 2023/2024 reporting period.



The IFCA will maintain and implement an effective communication strategy.

OUTCOME(S)

The IFCA will maintain a database of stakeholder contacts that will have been reviewed and updated by 31 March each year.

The IFCA will have completed a review of its communication strategy and implementation plan by 31 March each year.

PERFORMANCE INDICATOR(S) UPDATE 2023/2024

Through its fishing permitting schemes NEIFCA maintains an annual database of some 3,000 individual contacts covering both commercial and recreational fishing.

The authority maintains a formal communication strategy which is reviewed annually.

Copies of annual plans are sent to the Department for Environment, Food and Rural Affairs (Defra) Secretary of State by 30 April each year.

The IFCA will maintain its website ensuring public access to current fisheries and conservation information for the district, including management requirements and byelaws. non-reserved IFCA Committee papers will be published.

The IFCA will have reviewed its website by the last working day of each month.

A new authority website 'went live' during at the beginning of April 2022 and information is updated on a daily basis which includes information on live projects or events occurring within the NEIFCA district.

Copies of annual reports are sent to Defra's Secretary of State by 30 November in the year in which they are published.

The IFCA will contribute to co-ordinated activity at a national level.

OUTCOME(S)

By 31 March each year the IFCA will have participated appropriately, proportionately and at the right level of delegation, in regional and national fisheries and conservation activity identified within the annual plan.

PERFORMANCE INDICATOR(S) UPDATE 2023/2024

Throughout the reporting year authority officers have engaged extensively in a wide range of nationally coordinated work streams including joint training and joint intelligence gathering through the National Association of IFCAs, the National IFCA Chief Officers Group, the National IFCA Technical Advisory Group and the National Inshore Marine Enforcement Group. In addition, throughout 2023/2024 NEIFCA played a full and active role in newly established Regional Fisheries Groups and maintained active engagement and participation in the national fisheries intelligence gathering programme. During 2024 the MMO, in partnership with IFCA's, commissioned 'Clue' a new joint fisheries intelligence database system. Since commissioning, NEIFCA has inputed over 60 intelligence reports onto the system.

The IFCA and its principle partners will have a clear understanding of the roles and responsibilities. Memoranda of Understanding (MoU) with MMO, Natural England, Environment Agency and Centre for Environment, Fisheries and Aquaculture Services (CEFAS) will be maintained.

The IFCA will have reviewed all of its MoUs by 31 March each year. There will be a clear plan in place to update MoUs where necessary, to an agreed standard.

National MoU's are maintained through the Association of IFCA's but more recently have largely been superseded by joint operational delivery groups such as the IFCA/MMO Strategic Operational Group, NIMEG and TAG.

The IFCA will publish its enforcement risk register and strategy, clearly setting out its approach to achieving regulatory compliance and potential sanctions that may be applied for infringements and/or offences.

OUTCOME(S)

The IFCA will ensure its enforcement risk register and strategy are published and available on its website from 1 April each year.

The IFCA will compile records of enforcement activity in a standard format; provide them to AIFCA for collation and publish them on its website.

PERFORMANCE INDICATOR(S) UPDATE 2023/2024

The authority publishes a comprehensive annual risk register which covers all aspects of risk including enforcement. The authority publishes details of its enforcement activity within its annual report and provides statistics to the National Association of IFCAs in a standard format.

The IFCA will manage operational activity and capture, record, evaluate and disseminate intelligence that is compatible with partner organisations. It is engaged in joint working with partner organisations.

Working to the National Intelligence Model (NIM) and participating actively through Tasking and Coordination Groups (TCGs). Throughout 2023/2024 Officers have been actively engaged in the joint fisheries intelligence gathering programme, collating, assessing and exchanging intelligence in accordance with NIM principles.

This work culminated in the commissioning of the 'Clue' system during 2023/2024. A new bespoke fisheries intelligence database managed by the MMO to enhance joint intelligence gathering with IFCAs.

This involved active participation in the TCG process including joint TCGs with MMO officers.

Warranted Inshore Fisheries and Conservation Officers (IFCOs) will be trained and accredited to nationally agreed standards. They will maintain professionalism and make appropriate interventions to deliver efficient, effective enforcement activity.

OUTCOME(S)

The IFCA will adopt the national code of conduct for IFCOs which will be reviewed annually and published on its website.

Warranted Officers attain accreditation. ALL undertaking continuing professional development.

PERFORMANCE INDICATOR(S) UPDATE 2023/204

Authority Officers undergo a wide range of training supported by a twelve month probationary process. That training incorporates an induction, an IFCA residential course and 'on-the-job' training and evaluation.

A national code of conduct for IFCA enforcement officers was agreed in 2010 and was adopted by the authority. It is reviewed annually.

The IFCA will identify issues likely to affect sustainable management of the marine environment in the IFC District; undertake risk assessment and gap analysis; review appropriateness of existing measures; evaluate management options and develop and implement proportionate marine management solutions.

OUTCOME(S)

The IFCA will record site-specific management considerations for Marine Protected Areas and report progress to the authority.

The IFCA will publish data analysis and evidence supporting new management measures, on its website management information (e.g. sampling and/ or survey results) will be collected periodically after new management measures have been implemented, to demonstrate the extent of effectiveness of the intervention.

PERFORMANCE INDICATOR(S) UPDATE 2023/2024

Authority officers have completed extensive site feature/activity interaction risk matrices for all Marine Protected Areas (MPAs), including European Marine Sites (EMSs) and Marine Conservation Zones (MCZs) occurring within the NEIFCA district. A significant supporting management programme commenced during 2013 prioritised towards high risk activities. This work was advanced during 2019/2020 with the confirmation of two regulations protecting features at Flamborough Head, Filey and the Humber Estuary. On the 1 December 2022 the Authority approved the extension of the protected Eelgrass area at Spurn Point in the Humber Estuary Byelaw The IFCA actively supports implementation of a well managed network of marine protected areas by: developing a range of criteria based management options; implementing management measures to ensure that inshore fisheries activities comply with the Marine and Coastal Access Act 2009 and the revised approach to managing commercial fisheries in European Marine Sites; and that local management contributes to delivery of targets for the Marine Strategy Framework Directive, Water Framework Directive and Marine Plans.

The IFCA will develop Fisheries Management Plans for priority species where appropriate. Shared objectives will be developed with identified partners; actions identified and best practice reflected so that management makes a contribution to sustainable development.

Proportionate regulation (for example introducing a legal mechanism such as a byelaw) is used as a last resort; The effectiveness of interventions to improve the delivery of beneficial outcomes is continuously monitored; and

There is a clear IFCA Committee process for dealing with agreed interventions quickly, efficiently and effectively, particularly for emergency byelaws.

OUTCOME(S)

The IFCA will include shared agreed objectives and actions from Fisheries Management Plans in its own annual plan, which will be published by 31 March each year.

Progress made in relevant Fisheries Management Plan areas, including maximum sustainable yield commitments, will be noted in the IFCA's annual report.

PERFORMANCE INDICATOR(S) UPDATE 2023/2024

The sustainable management of key lobster and edible crab stocks was further enhanced during 2019/2020 through measures introduced in the revised Crustacea Conservation byelaw. Protection for soft shelled and berried lobsters will help to bolster spawning stock of this species, while the introduction of a maximum pot size and reducing the maximum size of vessel permitted to fish within inshore areas are important effort controls that will help to ensure the continued viability of the regionally significant fishery. A new minimum size byelaw, developed in collaboration with a number of other IFCAs, was also introduced, confirmed during February 2021. As was a catch return byelaw aimed at improving data capture to inform future management decisions.

A new Fisheries Management Plan has been adopted to support the inshore scallop dredging fishery. The plan has been informed by a four year pilot trial which commenced following the introduction of emergency control measures at the beginning of 2015. The plan describes the state of the stocks and the fishery derived from research undertaken by the authority, it outlines current national and local management policy and objectives, and highlights the conservation and fishery management measures in place to ensure a sustainable fishery. The plan will guide development of the dredge fishery, balancing the needs of different stakeholders.

At national level, during 2023/2024, NEIFCA is also fully engaged in the implementation of Fisheries Management Plans (FMPs) across key exploited stocks including King Scallop, crab and lobster, sea bass and whelk.

The IFCA will demonstrate its long-term strategic approach to sustainable marine management by having appropriate plan-making, review, update and amendment procedures in place. The IFCA will record its performance against corporate outcomes and indicators as soon as practically possible following the end of the financial year.

Staff performance management systems will be in place that link to the IFCA success criteria.

There will be an induction procedure for new joiners.

Staff training and development needs will be identified.

Performance will be managed and where necessary, improvement procedures will be followed.

OUTCOME(S)

The IFCA will publish a plan on its website by 31 March, setting out the main objectives and priorities for the next financial year. A copy will be sent to the Secretary of State.

After the end of each financial year, the IFCA will publish a report on its website describing its activities, performance and a summary of audited financial information in that year by 30 November. A copy will be sent to the Secretary of State.

IFCA staff will have annual performance management plans in place. Annual appraisals for all staff will have been completed by 31 May each year.

PERFORMANCE INDICATOR(S) UPDATE 2023/2024

The authority has produced an annual plan and annual report since 2010. The 2023/2024 plan was considered and endorsed by the committee on 14 March 2023 and submitted to the Secretary of State. The annual report covering the 2023/2024 period was submitted to the Secretary of State during November 2024.

A new staffing appraisal system commenced during November 2022 which incorporated performance related pay progression. This system enables a bespoke annual training plan to be set to meet individual staff needs underpinned by personal set of work objectives for the year ahead. All staffing appraisals were completed by 1 April 2024.

Staff performance management systems will be in place that link to the IFCA success criteria. There will be an induction procedure for new joiners. Staff training and development needs will be identified. Performance will be managed and where necessary, improvement procedures will be followed.

IFCA staff will have annual performance management plans in place. Annual appraisals for all staff will have been completed by 31 May each year.

During 2023/2024 the authority maintained a system of 'hybrid' meetings providing for attendance in person combined with virtual engagement to conduct its business. Agendas, supporting papers and minutes were published in accordance with the authority's standing orders and posted on the authority's website.

Standard operating procedures describe how data is captured and shared with principal partners.

OUTCOME(S)

The IFCA's contribution to Technical Advisory Group (TAG) and progress that it has made towards a national evidence needs programme will be recorded in the IFCA's annual report.

PERFORMANCE INDICATOR(S) UPDATE 2023/2024

The authority's environmental and scientific leads are fully engaged with other IFCA colleagues through the national IFCA Technical Advisory Group. Through this group, the authority's officers have developed and implemented standard operating practices across most of its work streams.

Non-confidential meta-data collected through the IFCA research programme should be recorded in a database available to the marine research community.

Non-confidential data is shared reducing the need for duplication of survey effort.

Authority officers share non-confidential meta data through MEDIN and 'one drive' and improving internal data sharing within the authority's membership remains an ongoing work stream.
