

How to add new Statutory Charge Categories to your Apex RMS system.

New Statutory Fees will apply from 6th April 2023.

This guide will help you through the stages to amend the Statutory Charges in your Apex RMS system.

Although the charges will increase, the Classes of Vehicles and the Scenario's will remain the same.

You will find the Statutory Charge Categories in your RMS system in your Recovery Screen by hovering over the "Setup" icon,

then from the dropdown list, go to "Operational" and then "Statutory Categories"



Here you will see your Statutory Charge Categories List. This can be printed off by clicking on the "Print Category List" button on the bottom right corner of the list.

Printing off this list will be helpful as you add your new charges.

This list gives you three important pieces of information, firstly it gives you the "Code". This is a 3 digit Code that must be unique for each line. If you try to use a Code that is already being used, the system will flag a conflict.



The Codes are the only part of the Charge List that need to be unique.

The first field is "Code". Remember this needs to be a unique code of one, two or three digits, numbers and or letters.

This needs to be the same as the original to save confusion.
