
WOUND INFECTIONS

Most wound and skin infections relate to streptococcal and staphylococcal infections

If standard antibiotics not taking effect by 3 days SWAB 'The Levine technique'

Revisit patient co-morbidities & if leg ulcer ensure using optimum compression

WINTER AND WOUNDS

Cold weather worsens blood flood flow which will result in less oxygen to wounds making healing slower and more susceptible to wound infections. Cold, flu and other winter ailments which affect the frail elderly the most will also impact on developing wounds. Pressure ulcers are more common as people are less mobile, if unwell or too cold to go out. When central heating is in use, the skin often becomes dry, it is more of a challenge to keep hydrated which leads to more fragile skin. It is crucial to ensure those vulnerable are kept warm, orally hydrated, good skin care meaning well moisturised skin to prevent skin from cracking and to restore the skin barrier, additionally mobility encouraged.

Free dressing samples and other products must not be accepted from Company Reps for "trial use" on your patients or clients. If free samples are used, you would take personal responsibility and accountability. There are procedures to follow to evaluate dressings that are not on formulary as samples may not be safe to use on patients. WOUND FORMULARY / ONPOS CHANGES

There are new Wound formulary / ONPOS Webinars 30-minute sessions after Area prescribing Committee meeting to update all clinicians delivering wound care to notify of any changes to dressings formulary / ONPOS. National guidance recommends formulary compliance, this gives a standard of practice in each NHS organisation, by using a bulk order system like Onpos / NHSSC there is less wastage, and dressings are readily available to use. Categories wise, there is a great selection of antimicrobial's, foams, absorbents, skin tear products which covers majority wound types. Prescriptions should only be requested in exceptional circumstances to treat atypical wounds and under specialist guidance as per FP10 prescribing principles Dressings on FP10 - prescribing principles for primary care - December 2021.pdf

A rare dermatological condition: What is Hidradenitis suppurativa:

Hidradenitis suppurativa (HS) is an incurable, debilitating chronic skin disease, reported to affect 1-4% of the general population with disease onset occurring typically in young adulthood. It often causes deep set skin lesions, abscesses, sinus tracks and irreversible skin damage. Patients need to be under the care of dermatology and HS clinics to ensure optimum treatment is provided. HidraWear may be recommended, it is the only HS-specific wearable wound care system available, intended for home use by patients who change their own dressings. This must be under the guidance of HS clinics and are not usually provided for those with mild HS. HidraWear on an individual patient basis following assessment in the Secondary Care HS clinic would be the only indication. The garment requires monitoring of effectiveness and measuring to guarantee fit. Microsoft Word - Position Statement - Prescribing HidraWear FINAL.docx
