Regulatory requirements for IPC Lead role

- Health and Social Care Act 2008: code of practice on the prevention and control of infections and related guidance
 GOV.UK (www.gov.uk) states that
- 1.4 Outside of NHS organisations, the responsibilities of the DIPC are discharged by the IPC lead for the registered provider. This role will vary across adult social care, primary dental care, primary medical care, independent healthcare providers and independent sector ambulance providers.
- The IPC lead for the registered service provider should:
 - be responsible for the organisation's IPC (including cleanliness), the built environment (where appropriate) and antimicrobial stewardship programme, as well as management and structure and the establishment of relevant groups
 - oversee IPC policies and their implementation and work with other IPC system-wide leads when needed
 - the lead will report directly to the registered provider
 - promote respectful challenge of inappropriate practice amongst all workers and have the authority to set and challenge standards of cleanliness
 - assess the impact of all existing and new policies on infections and make recommendations for change
 - be an integral member of the organisation's governance, and safety teams and structures where they exist
 - produce an annual statement with regard to compliance with practice on IPC (including cleanliness) and make it available on request



NEW CQC quality standard on Infection Control

CQC will be more active in 2024 and may well look at the new IPC CQC quality standard as part of your inspection:

Infection prevention and control - Care Quality Commission (cgc.org.uk)

Essentials you need to have in place to pass (CQC could ask you to send them)

1. Infection Prevention Control Policy

- Up to date IPC policy including external contacts for advice & support.
- Policy needs to include management of infectious patient if they turned up in the waiting room what would you do?
- Policy must follow and reference IPC manual NHS England » National infection prevention and control
- Handling specimens process (in your IPC policy or separate policy)
- Cleaning & decontamination policies particularly for all re-usable equipment used with patients
- **2. Comprehensive IPC audit** completed within the last year with an action plan you are monitoring / completing or evidence of where you are tracking the actions found in the audit how do you do this?
- Hand Hygiene audits too if you have a light box use it ©
- 3. Annual IPC statement / report for the practice Health and Social Care Act 2008: code of practice on the prevention and control of infections and related guidance GOV.UK (www.gov.uk) document your practice performance over the last year against the 10 IPC criterion.
 - Where do you discuss this report? Can you evidence you have discussed it in clinical meeting minutes and any actions from it.





CQC IPC essentials continued

- **4. General Cleaning audits** these should be documented monthly checks of what the cleaner says they are doing ideally the cleaning company manager should be doing these but if not, the practice will have to do them
- **5. What training has the IPC Lead** had and how do they stay up to date?
 - Look at Surrey Training Hub for relevant training for the role if you haven't had any <u>Infection Prevention Control Lead Training</u>: Surrey Training Hub
 - The Primary Care IPC forum was commented positively on in a CQC inspection as a good way to stay up to date!

If CQC go in: (they will always go in to inspect this standard, if they choose to look at it)

- 5. Clinical Cleaning logs (3 months worth)
 - Make sure you have a daily initialled record that clinicians have cleaning equipment like stethoscope, BP cuff etc between patients.
- **6. Ensure you have had a deep clean** including all **high and low** surfaces top of door frames / cupboards, curtain rails, under couches they will check its dust free!
 - Cleaners adhering to national cleaning standards NHS England » National Standards of Healthcare Cleanliness 2021
 - Sharps bins not being opened for more than 3 months not too full
 - Clinical curtains changed 6 monthly
 - Correct bins used outside clinical waste bin locked
- 7. Stock check records of all expiry dates on drugs and dressings and everything else with an expiry date

IPC Lead role- training & development requirements

- IPC lead role falls into the "Introduction level" category
- Accredited learning opportunities for achieving Introduction level are being provided and funded by Surrey Training Hub, as follows on the next slide
- CQC will expect to see that this education framework had been acknowledged by your organisation and that you have been given the opportunity to access these learning courses, in order that you can develop your knowledge to enable you to fulfil the IPC lead role (as detailed in slide 3





IPC Lead Role training & development opportunities:

- The recommended training for IPC Leads is to complete <u>Skills for Health modules 1&2</u>. Each module costs £12 and you can reclaim the full £24 via our <u>CPD Application Process</u>. It is also important to understand the regulatory requirements. Cleaning Products to use in GP Surgeries

- Have you looked in your cleaners cupboard recently?
- Are they using clinically appropriate cleaning products?
- No String Mops replace with disposable colour coded Mop heads
- Neutral detergent, such as Hospec (from NHS supplies) is effective for general cleaning.
- In toilets would advise routinely using a combined detergent & chlorine product, such as Actichlor Plus or Chlorclean, as urine spills and aerosols from diarrhoea and or vomiting are invisible to the eye.
- Cleaning staff must be COSHH trained to use any cleaning or disinfectant product.
- Going round practices I see quite a few products that are not appropriate for clinical environments and still seeing lots of string mops – particularly if you have a local cleaner rather than a cleaning company – please check!
- Cleaners often seem to have one high duster just moving dust around the practice! Should place a Clinel or similar wipe around the duster and dust tops of cupboards, tops of curtain rails and under clinical couches check yours now!
