2. STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

Lewisham Citizens Advice Bureaux Ltd. is a registered charity and a company limited by guarantee. Lewisham Citizens Advice Bureaux Ltd. is also known and referred to as Citizens Advice Lewisham (CAL). The maximum liability of each member is limited to £1. At 31 March 2019 the company had 9 members. Citizens Advice Lewisham is governed by its Memorandum and Articles of Association as amended on 7th November 2013.

Citizens Advice Lewisham was incorporated as a company limited by guarantee on 27th March 1985. The charity commenced operations on 27th March 1985 at which date the assets and liabilities of the unincorporated Citizens Advice Lewisham (CAL) were acquired.

Recruitment, Appointment of Trustees

Our Trustees, who are also directors of the charity, are elected at our Annual General Meeting. Trustees may co-opt up to six people onto the Trustee Board to ensure the Board is broadly representative of the community, and to fill any specific vacancy and skills needed to carry out our responsibilities effectively (e.g. Treasurer). Co-opted members must stand down at the Annual General Meeting following their co-option, but they are eligible to stand for election.

One third of the elected Trustees (the longest serving since previous election) stands down at each AGM, and is eligible to stand for re-election. We invite nominations for Trustees through our annual mailing to stakeholders and local community organisations. Co-opted Trustees are recruited through a variety of methods, including direct advertising in the relevant media (e.g. the internet, local newspapers.)

The Board regularly reviews its membership to ensure there is a broad range of relevant skills and experiences sufficient to carry out its duties.

A separate process agreed by the Trustee Board is followed for the election of the Chair. The reference and administrative details above identify the constituencies that elected each of the current Trustees, where applicable. No other persons or bodies external to the charity were entitled to appoint persons to the Trustee Board.

Training of Trustees

All new Trustees are buddied with established Board members and are invited to attend an induction training session at Citizens Advice London office, to find out more about the Citizens Advice service nationally and the role of Trustees. They participate in a planned induction which includes:

- Access to key governance documents such as the governance manual, financial procedures and annual report.
- Good governance guidance – relevant Charity Commission guides and references to high performing boards including Harvard and ICOSA reports.
- Service tour introducing the different aspects of the service and identifying key team members.
- Introduction to stakeholders and client profile with the CEO.
- Bi-annual review with the Chair to establish objectives and progress.
- Workshop with Citizens Advice nationally to understand the member relationship.

All new Trustees receive an email address, access to the Citizens Advice portal BMIS and complete their confidentiality and declaration of interests forms. Where required, the Trustees are DBS checked. All Trustees are able to arrange bureaux visits to meet our Service Manager and find out more about our work. An insight day is held annually, organised by volunteers to enable Trustees to observe the service delivery and understand the nature of the enquiries presented by clients.

Organisational Structure

CAL is governed by its Trustee Board which is responsible for setting the strategic direction and policy of the charity. The Trustees carry the ultimate responsibility for the conduct of CAL and for ensuring that the charity satisfies its legal and contractual obligations. Trustees meet as a minimum quarterly and delegate the day-to-day operation of the organisation to senior management. The Trustee Board is independent from management. A register of members' interests is maintained at the registered office and is available to the public.

Related Parties

CAL is a member of Citizens Advice, the operating name of the National Association of Citizens Advice Bureaux, which provides a framework for standards of advice and casework management as well as monitoring progress against these standards. Operating policies are independently determined by the Trustee Board of CAL in order to fulfil its charitable objects and comply with the national membership requirements.

The charity also co-operates and liaises with a number of other advisory services, local charities and local authority departments on behalf of clients. Where one of the Trustees holds the position of trustee/director of another charity or is a decision maker within the local authority, they may be involved in discussions regarding that other charity or department but not in the ultimate decision-making process.

Major risks

The Trustees recognise that any major risks to which the charity is exposed need to be reviewed and systems put in place to mitigate those risks. To that end CAL is continually monitoring and managing its risk, reviewing the corporate risk register and ensuring action plans are in place to mitigate its key risks. CAL has worked on a Corporate Risk Management exercise and the Trustee Board agreed to a risk based approach to the reserves policy.

The top three risks for the organisation relate to:

1. Managing and leading the Advice Lewisham Consortium to adapt to resident demand and deliver a high performing, value for money service that includes handling 90% of close to 6,000 telephone calls per quarter with 80% of these answered within a few minutes.
2. Maintaining and improving morale and performance among a dedicated team of staff and volunteers that have come through considerable change in the last few years including the merger of three offices and relocation, the integration of advice services and introduction of triaging to ensure that intensive support is prioritised for the most vulnerable residents.
3. Diversifying the income base at a time when competition for funding from trusts and foundations has increased significantly and opportunities for smaller organisations to bid for tenders are limited.

The Trustees keep the pension liability associated with the National Citizens Advice Bureau (NACAB) pension scheme under review, but do not currently consider it to be a major risk as there is an appropriate recovery plan in place. The scheme is closed to future accrual and there are no active members, so there is no likelihood of triggering a cessation event for this scheme.

Internal risks are minimised by implementing procedures for authorisation of all transactions and projects and ensuring consistent quality of delivery for all operational aspects of the charity. These procedures are periodically reviewed to ensure that they still meet the needs of the charity.

3. OBJECTIVES AND ACTIVITIES

Objects

The charity's objects are to promote any charitable purpose for the benefit of the community in the administrative area of the London Borough of Lewisham and surrounding areas, by the advancement of education, the protection of health and the relief of poverty, sickness and distress.

CAL aims to provide free, confidential, impartial and independent advice and information for the benefit of the local community, to exercise a responsible influence on the development of social policies and services and to ensure individuals do not suffer through a lack of knowledge or an inability to express their needs effectively.

Objectives, Strategies and Activities for the Year

CAL's vision is of a Lewisham where everyone can access help to deal with the issues they face, and where decision makers respond to people affected by their decisions.

- We exist to serve the needs of people who live or work within or near the London Borough of Lewisham.
- We provide the information and advice people need to address the problems they face and campaign for positive change, for all the people of Lewisham.
- We are proud to work with a large number of volunteers to deliver our services, alongside our paid staff.
- We are a lead member of Advice Lewisham, a partnership of the main free advice providers in Lewisham and a strategic partner to Lewisham Council.
- We are a member of Citizens Advice, our national membership body and actively promote the principles underpinning the whole Citizens Advice service.
- We are independent and impartial
- Our services are free and confidential
- We value diversity, promote equality and challenge discrimination

In addition to the continuing provision of high quality advisory services to the local community the Trustees' primary objective for the year was to further develop the Leamore Centre as the operating base for the team and the 10 line call centre Advice Line on behalf of the Advice Lewisham Partnership.

Public Benefit

The Trustees have paid due regard to the Charity Commission's guidance on public benefit in deciding the activities undertaken by CAL during the year. The Trustees are satisfied that the information provided in the report and accounts meets the public benefit reporting requirements.

The principal activity of CAL remained the provision of free, confidential, independent and impartial advice, information and counsel for members of the public through face-to-face consultations and by telephone. This was provided through our Leamore Community Hub and the Advice Lewisham Advice Line. In addition to generalist advice, specialist welfare benefit and debt advice was also provided.

Contribution of Volunteers

The charity receives help and support in the form of voluntary assistance in advising the public and administering the charity.

4. ACHIEVEMENTS AND PERFORMANCE

Charitable Activities

The key achievements in the year were:

- Securing a major 3 year grant from the London Borough of Lewisham on behalf of the Advice Lewisham Partnership
- Being the lead delivery agency for the Advice Lewisham partners serving 18,192 client contacts through the Advice Line and 5,330 in centres across the borough including the Leamore Drop-In.
- Helping 1,573 residents to manage their debt and money matters.
- Serving almost 1,716 clients for Debt Free London (previously the Money Advice Service) and generating £1.9 million in outcomes.
- Working in partnership with Southwark Law Centre to secure resources for an Immigration Officer to join the two housing case workers in the Lewisham Law Centre.
- Recruiting, training and managing a team of 66 talented volunteers contributing nearly £400,000 to the organisation.

Fundraising Activities

Total income for the year was £1,001,435 an increase of £9,324 on 2017-18. The primary cause of this increase was a new grant from the Trust for London to set up the Lewisham Law Centre.

In addition, new grants were received for partnership work with DWP on Universal Credit which is now the new funding programme Help to Claim. We also benefitted from a grant from the Government's Business, Energy and Industrial Strategy Department to delivery energy advice.

Achievements and Performance

Progress is assessed against agreed annual objectives delivered by the CEO and the skilled team of staff and volunteers.

Promoting equality and diversity continues to be a key objective for the organisation. During 2018-19, around 54% of our clients are BAME and 43% are disabled or have long term conditions. Our face to face services are prioritized for the most vulnerable. Among our clients, we recognize that the need for the support is greatest amongst those with mental health conditions, disabilities and where they are at risk of homelessness. Caseworkers secure benefits in around 90% of the appeals they conduct.

Research and campaigns to influence policy is a core objective for CAL. Following the roll-out of Universal Credit we have worked with clients to understand the pressures they face. The five week waiting time for payments has been a particular concern and we were pleased to support national efforts to campaign for change. The Council Tax enforcement was also flagged as an issue by clients.

One of the ambitions of the Advice Lewisham Partnership has been to provide a joined up and seamless service for local residents. The Freephone number is used on average by about 100 people per day and establishes a single first point of contact for clients. Most can be helped straight away but those requiring casework are triaged for appointments. In addition, CAL has maintained a hub where clients can drop in for information and assistance with on-line forms and services.

The new Lewisham Law Service started in September 2018. A total of 122 referrals were received with 46 taken on. Casework has so far, focussed on housing.

5. FINANCIAL REVIEW

Financial Position

Following the one off costs incurred in 2016-17, which had a significant impact on the charity's reserves, the financial position has stabilised, with a surplus being made in the year.

Following the change in accounting treatment in 2016-17 the charity's liability associated with a NACAB pension scheme is reflected in these accounts. This liability represents the net present value of the charity's deficit contributions under a recovery plan. It is worth noting that any crystallisation of the underlying liabilities, shown in note 19, would be managed at a national level. Please see notes 18 and 19 for more information.

Incoming resources in the year were £1,001,435 (2017-18: £992,111). Of this £838,007 (2017-18: £821,043) related to project restricted activities.

A surplus of £116,765 was made in the year (2017-18: £101,127). At 31 March 2019 total reserves were £189,572 of which £163,363 represented unrestricted funds.

Reserves Policy

The Trustees of CAL are required to ensure that free monies are available in each financial year to meet any reasonable foreseeable contingency. They will work to ensure that funding is derived from as wide a variety of sources as possible. They will take all necessary steps to ensure that at no time within this period would it be possible for the cessation of one or more funding streams to present so serious a challenge to the future of the organisation that it could not be managed so as to continue to provide a best value advice service.

In reviewing the potential costs that could arise should a significant reduction in income be incurred the Trustees have adopted a risk based approach to the reserves target. This policy takes account of two realities:

- Were there to be material further cuts to existing funding sources our staffing model with its dependency on volunteers and so on represents a lower financial risk to the bureau. Our key funders London Borough of Lewisham and Capitalise have been sensitive to the impact of any cuts and provided good lead times and practical solutions to any potential redundancy costs i.e. such costs allowed against their funding.

- If funding were continued but a different organisation required to deliver these services, then of course Transfer of Undertakings (Protection of Employment Rights) would apply which would reduce our financial exposure due to lower redundancy costs.

Whilst the analysis of risks suggests that it is possible to hold lower reserves, the Trustees believe that a reserves level equivalent to 3 months' running costs is appropriate for a charity such as CAL, in line with the policy of Citizens Advice at national level. Over the next 3 years, however, with funding relatively secure and the need to prioritise staff and service, Trustees are content to hold general unrestricted reserves (excluding pension liability) equivalent to 2 months' projected expenditure, which for 2018-19 was approximately £150,000, and to build towards 3 months' expenditure over the period to 2022.

Further detail about the funds held is given in note 15.

Principal Funding Sources

The Trustees extend their gratitude to Lewisham Council who continued to support the core operating capacity of the charity. Additionally project-specific funding was received from:

- London & Quadrant and Phoenix Community Housing for specialist money advice and generalist advice to their tenants.
- Citizens Advice for our Energy Best Deal project, helping clients with issues around fuel and directly from the Business, Enterprise and Industrial Strategy Department.
- Housing Department and DWP for Universal Support.
- Capitalise (now Debt Free London) and from Money and Pension Service.

The charity did not have any borrowings from either providers of funding or other sources at the balance sheet date.

Funds in Deficit

No funds were in deficit at the balance sheet date.

Investment Policy

As required in its Memorandum paragraph 3.19, in furtherance of its objects, and for no other purposes, the charity has the power to invest the monies of the charity not immediately required for its purposes in or upon such investments, securities or property as may be thought fit, subject nevertheless to such conditions and such consents as may for the time being be imposed or required by law.

Our structured training programme provides a robust introduction to the legislative framework around advice and information services and allows people to improve their skills in listening to clients and helping them in their journey.

The staff and volunteer team are highly dedicated and they will be supported to deliver a strong, consistent and reliable service that supports as many people as possible who need information and advice but in particular the most disadvantaged.

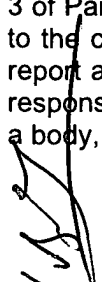
Auditor's responsibilities for the audit of the financial statements

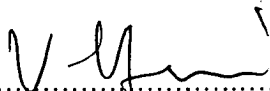

1. Accounting policies

a) Basis of preparation

The charity constitutes a public benefit entity as defined by FRS 102

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), the Charities Act 2011, the Companies Act 2006 and UK Generally Accepted Accounting Practice.

The financial statements are prepared on a going concern basis under the historical cost convention, modified to include certain items at fair value. The financial statements are prepared in sterling which is the functional currency of the charity.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

b) Tangible fixed assets and depreciation

The costs of minor additions costing below £1,000 are not capitalised. This policy is reviewed periodically by the trustees.

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Computer and office equipment	- 33% straight line or over whole term of the lease
Fixtures and fittings	- 33% straight line or over whole term of the lease

c) Income recognition

Contract and grant income is accounted for in the Statement of Financial Activities ("SOFA") when the charity has entitlement to the income, receipt is probable and amounts can be measured with reasonable certainty. Income received which relates to a future accounting period is recognised in creditors as deferred income. Bank interest is recognised on a receivable basis. Donations are recognised upon receipt.

d) Expenditure recognition

Expenditure is recognised on an accruals basis as a liability when incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Charitable expenditure comprises services supplied and activities undertaken which are identifiable as wholly or mainly in support of the charity's objectives.

Support costs are those costs which enable the charitable activities to be undertaken and include overheads and general property maintenance. Where activities incurred relate to more than one cost category, they are apportioned on the most appropriate basis, and predominantly with reference to staff time, on a reasonable and consistent basis.

Governance costs are those costs associated with the governance arrangements of the charity, and these include audit, legal advice for trustees, costs associated with trustee meetings and the cost of the preparation of the statutory financial statements.

1. Accounting policies/cont'd...

e) Fund accounting

The unrestricted general funds are those funds that are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Restricted funds are those funds which are to be used in accordance with specific restrictions imposed by the donors. Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

f) Financial instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

g) Operating leases

Rentals under operating leases are charged to the SOFA on a straight – line basis over the lease term.

h) Pension costs

CAL participates in 2 pension schemes;

Contributions payable under the schemes are charged to the Statement of Financial Activities in the year to which they refer:

a) The Pension Trust Growth Plan has four different series within the one pension scheme. CAL participates in two of these series. It previously entered staff into a defined benefit series and it now enrolls new staff into the defined contribution one.

The defined benefit series had been classified as a defined contribution “money purchase” scheme, but has now been redesignated as a defined benefit scheme because of the guarantee within the scheme that the value attributed to each member will not be less than the accumulated contributions. Consequently this places a potential contingent liability on employers, see also note 18, although CAL has no deficit contributions payable under the scheme. The pension contributions charged in these accounts represent the amounts payable by the company for this scheme in respect of the year 2018-19.

b) National Association of Citizens Advice Bureaux Pension and Assurance Plan (1991) is a defined benefit arrangement. However, this scheme is a multi-employer scheme and is also accounted for as a defined contribution scheme because the charity is unable to identify its share of the underlying assets and liabilities on a consistent and reasonable basis in accordance with Section 28 of FRS 102. As the charity has an agreed deficit contribution scheme in place, a liability has been included for the value of these future payments, discounted to their present value. This scheme was closed to future accrual with effect from 31 March 2008. Further details are provided in note 19.

19 NACAB pension scheme

Citizens Advice ('the Principal Employer') operates a defined benefit scheme ('the Plan') in the UK which provides both pensions in retirement and death benefits to members. Pension benefits are related to the members' final salaries at retirement and their length of service at the date they retired or left pensionable service. The Plan closed to future accrual on 31 March 2008. The Plan also contains some money purchase AVCs and protected rights funds, which are not included in these disclosures.

In accordance with the schedule of contributions in force over the 2019-20 accounting year, the contributions to the Plan for the year ending 31 March 2020 are expected to be £2,049,000, which includes £1,749,000 towards the deficit and £300,000 as an allowance for administration expenses and all scheme levies.

The Plan is a registered scheme under UK legislation. The Plan is subject to the scheme funding requirements outlined in UK legislation. The Plan is governed by the Plan's Trust Deed and Rules dated 4 April 2011. The trustee is responsible for the operation and the governance of the Plan, including making decisions regarding the Plan's funding investment strategy (although they are required to consult the Principal Employer).

A full actuarial valuation of the Plan was carried out as at 31 March 2019 by a qualified independent actuary, based upon membership data as at 31 March 2016 allowing for assumed membership movements over the period from this date.

The most recent formal actuarial valuation of the Plan was as at 31 March 2016 and revealed a funding deficit of £52,374,000. In the recovery plan agreed following the valuation, the Principal Employer and other participating employers agreed to pay deficit reduction contributions of £1,749,000 per annum with the view to eliminating the deficit by 31 December 2033.

The liabilities of the Plan are based on the current value of expected benefit payment cashflows to members of the Plan over the next 60 or more years. The average duration of the liabilities is approximately 16 years.

The Plan is exposed to actuarial risks such as market (investment) risk, interest rate risk, inflation risk, currency risk and longevity.
