Definitions

Service : Ian Bailey Racing Private Service
Information : Horseracing information provided by Ian Bailey Racing to Members of the Private Service
Member : A Member is an individual who has requested/applied to join the Service and has received a Personal Identification Number (PIN) to access the Information

Provision of Services

A Member's subscription shall come into force on the date notified on the membership confirmation letter/e-mail and shall continue thereafter for the subscription period unless terminated earlier.

Any breach of the terms of conditions may result in the Member being removed from the Service without notice or refund.

All fees once paid are non-refundable. However if the service ceases to operate for any reason a pro-rata refund of subscription fee will be issued.

Piracy, relay and/or re-transmission of information, whether for commercial gain or not, is strictly prohibited and Ian Bailey Racing will seek legal redress over any such action.
